## **DIGEST**

Mills (SB 145)

<u>Proposed law</u> amends <u>present law</u> to remove the names of the closed OCDD facilities: Greater New Orleans Supports and Services Center, Bayou Region Supports and Services Center, Northeast Supports and Services Center, Columbia Community Residential and Employment Services, Leesville Residential and Employment Services, Acadiana Region Supports and Services Center, Acadiana Employment Services at Eunice, and Acadiana Employment Services at Opelousas. Provides that the OCDD facilities remaining open include the Pinecrest Supports and Services Center, the Northwest Supports and Services Center, and the North Lake Supports and Services Center.

Effective upon signature of the governor or lapse of time for gubernatorial action.

(Amends R.S. 28:22.8(A) and 451.4(B); repeals R.S. 28:894(A)(5) and R.S. 36:259(C)(15), (17) through (20), (22), (25), and (26))
