#### 1 AN ACT 2 To amend and reenact R.S. 23:382(B), 384(A), the introductory paragraph of 384(B) and 3 (B)(2), (3), and (4) and (C), 385(B), 386, the introductory paragraph of 387 and 4 387(9), 388, 389, 390, and 391, relative to apprenticeship; to provide for prohibited 5 discrimination in employment; to provide collective bargaining contracts; to make 6 technical changes; to provide for exceptions; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. R.S. 23:382(B), 384(A), the introductory paragraph of 384(B) and (B)(2), 9 (3), and (4) and (C), 385(B), 386, the introductory paragraph of 387 and 387(9), 388, 389, 390 and 391 are hereby amended and reenacted to read as follows: 10 11 §382. Apprenticeship council \* 12 13 B. The apprenticeship council shall meet at the call of the executive director 14 or the director of apprenticeship and shall aid in formulating policies for the effective 15 administration of this Chapter. Subject to the approval of the executive director, the 16 apprenticeship council may recommend standards and procedures for registration 17 and de-registration of apprenticeship programs in conformity with established programs approved by the Office of Apprenticeship, United States Department of 18 19 Labor, Office of Apprenticeship and for approval of apprenticeship agreements 20 which in no case shall be lower than those prescribed by this Chapter and by the 21 Office of Apprenticeship, United States Department of Labor, Office of 22 **<u>Apprenticeship</u>** or lower than approved national standards; shall issue such rules 23 and regulations as may be necessary to carry out the intent and purposes thereof, and 24 shall perform such other functions as the executive director may direct. Not less than 25 once a year the apprenticeship council shall make a report, through the executive 26 director, of its activities and findings to the legislature and to the public.
