MUNICIPALITIES. Authorizes the governing authority of the city of Scott to levy an additional one cent sales tax, subject to voter approval. (gov sig)

2	To enact R.S. 47:338.24.5, relative to municipal sales and use taxes; to authorize the
3	governing authority for the city of Scott to levy and collect an additional sales and
4	use tax; to require voter approval; to provide for the use of the tax revenue; and to
5	provide for related matters.
6	Notice of intention to introduce this Act has been published.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 47:338.24.5 is hereby enacted to read as follows:
9	§338.24.5. City of Scott; authority to levy additional sales and use tax
10	A. The governing authority of the city of Scott may levy and collect an
11	additional sales and use tax not in excess of one percent within the corporate
12	limits of the municipality.
13	<b>B.</b> The tax authorized by this Section shall be in addition to all other
14	taxes which the city of Scott is authorized to levy and, pursuant to Section 29(B)
15	of Article VI of the Constitution of Louisiana, shall not be subject to the
16	combined rate limitation established in Section 29(A) of Article VI of the
17	Constitution of Louisiana nor to the rate limitations established by R.S. 47:338.1

1	and 338.54, nor shall it be included in the rate limitation of any other political
2	subdivision. The authority granted in this Section shall not limit any prior
3	taxing authority granted to the city of Scott or any other political subdivision
4	by any other provision of law, including any authority granted to any other
5	political subdivision to exceed any constitutional or statutory rate limitations.
6	<b>C.</b> The sales and use tax shall be imposed by ordinance of the governing
7	authority of the city of Scott and shall be levied upon the sale at retail, the use,
8	lease, or rental, the consumption, and the storage for use or consumption of
9	tangible personal property and on sales of services, all as defined in Chapter
10	2-D of this Subtitle; however, the ordinance imposing the tax shall be adopted
11	only after the proposed tax is approved by a majority of the qualified electors
12	voting on the proposition at an election held for that purpose and conducted in
13	accordance with the Louisiana Election Code.
14	<b>D.</b> The sales and use tax authorized by this Section shall be collected at
15	the same time and in the same manner as set forth in Chapter 2-D of this
16	<u>Subtitle.</u>
17	<b>E. Two-thirds of the proceeds of the tax authorized by this Section shall</b>
18	be used for emergency services provided by the fire and police departments and
19	one-third of the proceeds shall be used for parks and recreations, cultural
20	district, economic development, drainage, roads, and bridges.
21	F. On the official ballot to be used at the election there shall be printed
22	a proposition, upon which the electors of the municipality shall be permitted to
23	vote YES or NO, to adopt the proposition, which proposition shall read as
24	<u>follows:</u>
25	Do you support an additional sales and use tax of (insert
26	amount) per cent within the city of Scott, two-thirds of the
27	proceeds which shall be used solely for emergency services
28	provided by the fire and police departments and one-third
29	shall be used solely for parks and recreation, cultural

3	Section 2. This Act shall become effective upon signature by the governor or, if not
4	signed by the governor, upon expiration of the time for bills to become law without signature
5	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
6	vetoed by the governor and subsequently approved by the legislature, this Act shall become
7	effective on the day following such approval.

<u>Proposed law</u> authorizes the city of Scott, subject to voter approval, to levy an additional sales and use tax not to exceed 1%. Provides that the tax shall be in addition to all other authorized taxes and shall not be subject to rate limitations established by <u>present</u> <u>constitution</u> or <u>present law</u>. Further provides that the authority granted in <u>proposed law</u> shall not limit prior taxing authority granted to the city of Scott or any other political subdivision.

<u>Proposed law</u> further provides that the additional tax shall be collected at the same time and in the same manner as other sales and use taxes.

<u>Proposed law</u> further provides that two-thirds of the proceeds of the tax shall be used for emergency services provided by the fire and police departments and one-third of the proceeds shall be used for parks and recreations, cultural district, economic development, drainage, roads, and bridges.

<u>Proposed law</u> provides ballot proposition language.

Effective upon signature of governor or lapse of time for gubernatorial action.
