| 2 | To authorize and provide for the transfer of certain state property in Vermilion Parish; to |
| 3 | provide for the property descriptions; to provide for reservation of mineral rights; to |

| 5 | Be it enacted by the Legislature of Louisiana: |
| 6 | Section 1. The secretary of the Department of Wildlife and Fisheries, |
| 7 | notwithstanding any other provision of law to the contrary, is hereby authorized and |
| 8 | empowered to convey, transfer, assign, and deliver any interest, excluding mineral |
| 9 | rights, the state may have to all or any portion of the following described parcel of |
| 10 | property to the Vermilion Parish School Board, contingent upon written consent by BP |
| 11 | America Production Company or its successors: |
| 12 | A certain tract of land, including all improvements located thereon, |
| 13 | situated and lying south and west of the Warren Drainage Ditch Canal right of |
| 14 | way and being in Sections 10, 14, and 15, Township 13 South, Range 1 West, |
| 15 | containing approximately 340 acres, more or less, Parish of Vermilion, State of |
| 16 | Louisiana. |
| 17 | Section 2. In exchange for the above described property, the secretary of the |
| 18 | Department of Wildlife and Fisheries, notwithstanding any other provision of law to |
| 19 | the contrary, is hereby authorized and empowered to accept delivery of title to all or |
| 20 | any portion of the following described properties, excluding mineral rights, from the |
| 21 | Vermilion Parish School Board: |
| 22 | A. A certain tract of land, excluding mineral rights and including all |
| 23 | improvements located thereon, situated and being in Section 16, Township 14 |
| 24 | South, Range 2 West, containing approximately 640 acres, more or less, Parish |
| 25 | of Vermilion, State of Louisiana. |
| 26 | B. A certain tract of land, excluding mineral rights and including all |
| 27 | improvements located thereon, situated and being in Section 16, Township 16 |

| 3 | Section 3. The secretary of the Department of Wildlife and Fisheries, on behalf |
| 4 | of the state of Louisiana, is hereby authorized to enter into such agreements, covenants, |
| 5 | conditions, and stipulations and to execute such documents as necessary to properly |
| 6 | <u>effectuate any conveyance, transfer, assignment, or delivery of title, excluding mineral</u> |
| 7 | rights, to the properties described in Sections (1) and (2), and as more specifically |
| 8 | described in any such agreements entered into and documents executed by and between |
| 9 | the secretary of the Department of Wildlife and Fisheries and the Vermilion Parish |
| 10 | School Board, in exchange of consideration proportionate to the appraised value of the |
| 11 | properties. |
