| 13 | B. This Section shall not be construed to allow the sale or distribution |
| 14 | of any unwholesome food. |
| 15 | C. This Section shall not apply to any preparers of cakes and cookies |
| 16 | that are made at a home for sale, whose gross annual sales equal fifty thousand |
| 17 | dollars or more. |

DIGEST

<u>Proposed law</u> provides no provision of the state sanitary code or any provision of any other law or regulation that requires any equipment, design, construction, utensils, supplies, preparation, or services shall apply to the preparation of cakes and cookies in the home for sale.

<u>Proposed law</u> shall not apply to any preparers of cakes and cookies that are made at a home for sale, whose gross annual sales equal \$50,000 or more.

<u>Proposed law</u> provides the Department of Revenue shall provide to the Department of Health and Hospitals the names of all preparers of cakes and cookies that are made at home for sale, whose gross annual sales equal \$50,000 or more. Requires the Department of Revenue to promulgate necessary rules, regulations, and procedures in accordance with the APA.

Effective August 1, 2013.
