AN ACT

2	To amend and reenact R.S. 30:1154(A) and (C), relative to solar energy; to provide for
3	leases to explore, develop, and produce solar energy; to provide for the powers and
4	duties of the secretary of the Department of Natural Resources; to provide for terms,
5	conditions, and requirements of solar leases; to provide for operations and
6	construction during rulemaking; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 30:1154(A) and (C) are hereby amended and reenacted to read as
9	follows:
10	§1154. Regulations governing solar devices; solar leases
11	A. The secretary shall develop and adopt, in cooperation with affected
12	industry utility, agricultural, and solar industries, landowners, and consumer
13	representatives and after one or more public hearings, regulations governing solar
14	devices and property leases for the exploration, development, and production
15	of solar energy. The regulations shall be designed to encourage the development and
16	use of solar energy and to provide maximum information to the public concerning
17	solar devices. The regulations may include <u>all of</u> the following:
18	(1) Standards for testing, inspection, certification, sizing, capacity, and
19	installation of solar devices;, including spacing between installations and
20	setbacks.
21	(2) Provisions for the enforcement of the standards;
22	(3) Accreditation of laboratories to test and certify solar devices;
23	(4) Requirements for on-site inspection of solar devices, including specifying
24	methods for inspection, to determine compliance or noncompliance with the
25	standards <u>; </u>

SB NO. 185 ENROLLED 1 (5) Requirements for submission of any data resulting from the testing and 2 inspection of solar devices;. (6) Prohibitions on the sale of solar devices that do not meet minimum 3 4 requirements for safety, capacity, and durability as established by the secretary; and. 5 (7) Dissemination of the results of the testing, inspection, and certification program to the public. 6 7 (8) Minimum requirements for property leases for the exploration, development, and production of solar energy, including but not limited to 8 9 acreage, access, and maintenance of the property during the lease, 10 decommissioning, and final site closure upon termination of the lease, and 11 placement of this program within the department. The rules provided for in this 12 Paragraph shall be promulgated by the secretary, but not implemented until the secretary identifies funding through fees, federal grants, or other sources. 13 14 15 C.
