| 6 | Be it enacted by the Legislature of Louisiana: |
| 7 | Section 1. The commissioner of administration, notwithstanding any other |
| 8 | provision of law to the contrary, is hereby authorized and empowered to convey, |
| 9 | transfer, assign, lease, or deliver any interest, excluding mineral rights, the state may |
| 10 | have to all or any portion of the following described parcel of property to Rodney L. |
| 11 | Teutsch: |
| 12 | Approximately 6,970 square feet, more or less, of the dried lake bed of Lake |
| 13 | Bistineau, located in Section 28, Township 17 North, Range 10 West, Webster |
| 14 | Parish, Louisiana, and more particularly described as that portion of Lot 17-A |
| 15 | of Palmetto Beach Estates Subdivision which lies below the 148.6' contour line |
| 16 | per NGVD 29 elevation datum. |
| 17 | Section 2. The commissioner of administration is hereby authorized to enter |
| 18 | into such agreements, covenants, conditions, and stipulations and to execute such |
| 19 | documents as necessary to properly effectuate any conveyance, transfer, assignment, |
| 20 | lease, or delivery of title, excluding mineral rights, to the property described in |
| 21 | Section 1, and as more specifically described in any such agreements entered into and |
| 22 | documents executed by and between the commissioner of administration and Rodney |
| 23 | L. Teutsch, in exchange of consideration of at least one dollar per square foot of land |
| 24 | transferred but in no event less than the assessed value thereof. |

Section 3. The proceeds of any sale of all or any portion of the above parcel of 2 property shall be paid into the Aquatic Plant Control Fund and dedicated to aquatic 3 weed control and eradication in Lake Bistineau. Section 4. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 6 7 vetoed by the governor and subsequently approved by the legislature, this Act shall become 8 effective on the day following such approval.
