BY SENATORS MOUNT, MORRISH AND SMITH

1	AN ACT
2	To authorize and provide for the transfer of certain state property; to authorize the transfer
3	of certain state property in Calcasieu Parish; to provide for the property description;
4	to provide for reservation of mineral rights; to provide terms and conditions; and to
5	provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. The secretary of the Department of Health and Hospitals,
8	notwithstanding any other provision of law to the contrary, is hereby authorized and
9	empowered to convey, transfer, assign, and deliver any interest, excluding mineral
10	rights, the state may have to all or any portion of the following described parcel of
11	property to the Chennault International Airport Authority or the governing authority
12	of Calcasieu Parish:
13	A certain tract of land, including all improvements located thereon,
14	situated and lying in Section 2, Township 10 South, Range 8 West, Calcasieu
15	Parish, Louisiana, containing approximately 1.145 acres, more or less, and more
16	particularly described as: Commencing at a point North 45 degrees, 28 minutes,
17	31 seconds East 298.3 feet from Point "A" as shown on plat of survey of
18	boundary agreement of CAFB by D.W. Jessen and Associates, Civil Engineers,
19	Lake Charles, Louisiana, dated August 7, 1973, and filed in plat book 23, page
20	20 et seq., records of Calcasieu Parish, Louisiana; thence North 45 degrees, 28
21	minutes, 31 seconds East 226.85 feet; thence South 44 degrees, 37 minutes, 44
22	seconds East 220.0 feet; thence South 45 degrees, 28 minutes, 31 seconds West
23	228.0 feet; and thence North 44 degrees, 29 minutes, 09 seconds West 220.0 feet
24	to the point of commencement.
25	Section 2. The secretary of the Department of Health and Hospitals is hereby
26	authorized to enter into such agreements, covenants, conditions, and stipulations and
27	to execute such documents as necessary to properly effectuate any conveyance,
