AN ACT

2	To amend and reenact R.S. 40:1005(A), relative to the Prescription Monitoring Program
3	Advisory Council; to provide for the membership of the advisory council; and to
4	provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 40:1005(A) is hereby amended and reenacted to read as follows:
