INTERNET. Establishes the Louisiana Enhanced Governmental Access Portal within the division of administration and provides its functions and duties. (gov sig)

2	To enact Subpart E of Chapter 1 of Subtitle I of Title 39 of the Louisiana Revised Statutes
3	of 1950, to be comprised of R.S. 39:17 through 20, relative to governmental portal
4	services; to establish the Louisiana Enhanced Governmental Access Portal within the
5	division of administration; to provide for the duties and functions of the
6	commissioner of administration and chief information officer relative to the
7	governmental portal; to provide for outsourcing of certain portal services; to provide
8	for an effective date; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Subpart E of Chapter 1 of Subtitle I of Title 39 of the Louisiana Revised
11	Statutes of 1950, to be comprised of R.S. 39:17 through 20, is hereby enacted to read as
12	follows:
13	SUBPART E. LOUISIANA ENHANCED
14	GOVERNMENTAL ACCESS PORTAL
15	<u>§17. Louisiana Enhanced Governmental Access Portal</u>
16	The legislature hereby establishes the Louisiana Enhanced
17	Governmental Access Portal, a public instrumentality carrying out an essential

1	governmental function within the division of administration.
2	<u>§18. Definitions</u>
3	As used in this Subpart, the following words and phrases shall mean:
4	(1) "Agency" means any agency, board, commission, public
5	instrumentality, or political subdivision of the state, or any of the foregoing
6	entities acting on behalf of the state, that stores, gathers, or generates public
7	information or conducts public transactions.
8	(1.1) "CIO" means the chief information officer, head of the office of
9	information technology within the division of administration.
10	(2) "Portal" means any centralized electronic information system or
11	collection of websites and applications by which public information shall be
12	disseminated or collected, or transactions shall be conducted, via the Internet,
13	<u>dial-in modem, continuous link, or other electronic medium.</u>
14	(3) "Value-added charge" means the amount assessed and collected by
15	the portal from users of certain portal services to support its outsourced
16	operation so as not to require appropriated funds.
17	§19. Portal functions and duties
18	A. The CIO, under the direction of the commissioner of administration,
19	shall have the following duties relative to the oversight and operation of the
20	state of Louisiana's governmental portal:
21	(1) To provide oversight of the agencies within the division of
22	administration which supply and ensure electronic access to public information
23	and to permit the conduct of electronic transactions with government for
24	members of the public and business.
25	(2) To promote the use of electronic commerce for information access
26	and electronic transactions within the state in cooperation with the division of
27	administration.
28	(3) To provide appropriate oversight of any contracts relative to the
29	operation of the state's portal.

1	(4) To explore with the portal manager ways of expanding and
2	improving the amount and kind of electronic public information and electronic
3	transactions provided, increasing the utility and form of the electronic public
4	information and electronic transactions provided, and, where appropriate,
5	implement such changes as are necessary to be consistent with the provisions of
6	this Subpart.
7	(5) To serve in an advisory capacity to the division of administration and
8	other state agencies regarding the dissemination to and collection of electronic
9	state data for residents and businesses.
10	(6) To foster the principle of a user-supported portal for interactions
11	with government throughout the state.
12	B. All agencies may participate with the portal in providing assistance
13	and cooperation to achieve the purpose of this Subpart.
14	C. Electronic services and public information to be provided by or to
15	any agency may be specified pursuant to a contract or contracts between the
16	portal or its manager and such agency.
17	D. Nothing in this Subpart shall be construed to affect the availability
18	of public records in accordance with the Public Records Law as provided by
19	<u>R.S. 44:1, et seq.</u>
20	E. The commissioner of administration shall recommend any value-
21	added charges for transactions or classes of transactions conducted through the
22	portal for the review and approval of the Joint Legislative Committee on the
23	Budget.
24	F. Nothing herein shall apply to postsecondary education institution
25	portals used to support faculty and students, nor to the Louisiana State
26	University Health Electronic Health Record program established to provide
27	patients and their treating medical team with access to patient medical
28	information.
29	<u>§20. Outsourced portal manager; duties and rights</u>

1	A. The CIO, under the direction of the commissioner of administration,
2	shall oversee a competitive bid process to contract with a private entity to serve
3	as outsourced portal manager after developing criteria and specifications for
4	the portal manager's qualifications and duties.
5	B. The commissioner of administration shall negotiate and enter into a
6	contract with the portal manager to develop, operate, manage, maintain, and
7	expand the portal.
8	C. In addition, the portal manager shall perform the following functions:
9	(1) Prepare an initial multi-year strategic portal business plan and
10	update the plan yearly in consultation with and under the oversight of the
11	commissioner of administration.
12	(2) Process, or arrange for the processing of all financial transactions
13	involving use of the portal and portal operations, receive and disburse moneys
14	in connection therewith, and keep accurate records of the same.
15	(3) Submit to the commissioner of administration quarterly unaudited
16	portal financial reports, an annual financial audit by an independent audit firm,
17	an annual portal operations report, and any other portal information
18	reasonably requested by the commissioner of administration.
19	(4) Use its own employees or subcontractors for its performance.
20	(5) Use commercially reasonable procedures for the physical and
21	electronic security of the portal and the transactions it conducts.
22	(6) Make the initial capital investment, in exchange for a multi-year
23	contract, to capitalize the portal's operations and periodic expansions of service
24	and such subsequent capital investments as it shall deem advisable.
25	(7) Fund ongoing portal operations through online transactions for
26	which a value-added charge is collected.
27	Section 2. This Act shall become effective upon signature by the governor or, if not
28	signed by the governor, upon expiration of the time for bills to become law without signature
29	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

effective on the day following such approval.

Michot (SB 213)

<u>Proposed law</u> establishes the Louisiana Enhanced Governmental Access Portal, a public instrumentality carrying out an essential governmental function, within the division of administration.

<u>Proposed law</u> provides for certain duties the CIO, under the direction of the commissioner of administration, shall exercise relative to the government portal, including, among others:

- Sponsoring an online electronic portal to provide electronic access to public information and to permit electronic transactions with government for members of the public and business.
- Promoting the use of electronic commerce for information access and electronic transactions within the state.
- Fostering the principle of a user-supported portal for interactions with government throughout the state.

<u>Proposed law</u> provides that the commissioner of administration shall recommend any charges for transactions or classes of transactions for the review and approval of the Joint Legislative Committee on the Budget. Excludes applicability of such provisions affecting the Public Records Law. Further excludes applicability of such provisions affecting postsecondary education institution portals used to support faculty and students or the LSU Health Electronic Health Record program.

<u>Proposed law</u> provides that the CIO, under the supervision of the commissioner of administration, shall use a competitive bid process to contract with a private entity to serve as outsourced portal manager after developing criteria and specifications for the portal manager's qualifications and duties.

<u>Proposed law</u> provides that the portal manager shall perform various functions, including:

Preparing an initial multi-year strategic portal business plan and update the plan yearly in consultation with and under the oversight of the commissioner of administration.

Submitting to the commissioner of administration quarterly unaudited portal financial reports, an annual financial audit by an independent audit firm, an annual portal operations report, and any other portal information reasonably requested by the commissioner of administration.

Effective upon signature of the governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by Senate

- 4. Provides that the commissioner of administration shall recommend any charges for transactions or classes of transactions for the review and approval of the Joint Legislative Committee on the Budget.
- 5. Excludes applicability of such provisions affecting postsecondary education institution portals used to support faculty and students or the LSU Health Electronic Health Record program.
- 6. Provides that the CIO, under the direction of the commissioner of administration, shall oversee the outsourced portal management.
