3	reports; to require the office of facility planning and control to submit to the Joint

5	projects which do not have a fully executed cooperative endeavor agreement, a
6	design contract, or are not proceeding with construction, and the reasons therefor; to
7	provide for a copy of the report to be sent to each legislator whose district includes
8	one or more projects on the list; to provide for an effective date; and to provide for
9	related matters.
10	Be it enacted by the Legislature of Louisiana:
11	Section 1. R.S. 39:105(B) is hereby amended and reenacted and R.S. 39:105(C) is
12	hereby enacted to read as follows:
13	§105. Capital Outlay reports to Joint Legislative Committee on Capital Outlay
14	* * *
15	B.(1) The office of facility planning and control and any state agency
16	authorized to administer capital outlay appropriations shall submit to the Joint
17	Legislative Committee on Capital Outlay, an annual written progress report no
18	later than the first day of February, of the nonstate projects included in the
19	current year's capital outlay budget which have been funded by the legislature,
20	whether such funding was by appropriation or by bond authorization for
21	which:
22	(a) The cooperative endeavor agreement or any amendments thereto,
23	with the state have not been fully executed. The project manager and the
24	nonstate entity shall give a written explanation as to why the agreement has not
25	been fully executed.

1	(b) The nonstate projects which have a fully executed cooperative
2	endeavor or amendment but which have not received the approval of the office
3	of facility planning, of a proposed contract for the design or engineering of the
4	project, including an explanation by the project manager and the nonstate
5	entity as to the reason the contract has not been fully approved.
6	(c) The nonstate projects which have a fully executed cooperative
7	endeavor, have completed the design phase, and have not begun the
8	construction phase of the project, including an explanation of the reasons that
9	construction has not begun by the project manager and the nonstate entity.
10	(2) A copy of each report shall be sent to each member of the legislature
11	whose district includes one or more projects on the list.
12	$\underline{\mathbf{C}}$. The office of facility planning and control shall submit the report in a
13	format that can be edited.
14	Section 2. This Act shall become effective upon signature by the governor or, if not
15	signed by the governor, upon expiration of the time for bills to become law without signature
16	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
17	vetoed by the governor and subsequently approved by the legislature, this Act shall become
