| 10 | A.(1) Any person who becomes a candidate for an office for which the holder               |
| 11 | of the office is required to file financial disclosure statements pursuant to R.S.        |
| 12 | 42:1124, 1124.2, or 1124.3 shall file a financial disclosure statement as required by     |
| 13 | R.S. 42:1124, 1124.2, or 1124.3 for the office for which he is a candidate. The           |
| 14 | statement required by this Section shall be filed within three business days after the    |
| 15 | close of the qualifying period during which the candidate files his notice of             |
| 16 | candidacy for the office. If the person is required by R.S. 42:1124, 1124.2, or 1124.3    |
| 17 | to file a statement for the office for which he is a candidate, such filing shall satisfy |
| 18 | the requirements of this Section.   |
| 19 | (2) Any person who becomes a candidate for an office prior to April                       |
| 20 | fifteenth of any calendar year shall not be required to certify on his personal           |
| 21 | financial disclosure report that he has filed his federal and state income tax            |
| 22 | returns or filed for an extension thereof for the prior year.                             |
