6	Section 1. R.S. 47:305(D)(1)(k) and (4)(a) are hereby amended and reenacted and		
7	R.S. 47:337.9(C)(14.1) is hereby enacted to read as follows:		
8	§305. Exclusions and exemptions from the tax

10	D.(1) The sale at retail, the use, the consumption, the distribution, and the		
11	storage to be used or consumed in the taxing jurisdiction of the following tangible		
12	personal property is hereby specifically exempted from the tax imposed by taxing		
13	authorities, except as otherwise provided in this Paragraph:

15	(k)(i) Solely for purposes of the state sales and use tax, orthotic, including		
16	prescription eyeglasses and contact lenses, and prosthetic devices and wheelchairs		
17	and wheelchair lifts prescribed by physicians, optometrists or licensed chiropractors		
18	for personal consumption or use.		
19	(ii) Solely for purposes of the sales and use tax of political subdivisions,		
20	the sale to, or the purchase by, an individual or by a medical service provider		
21	such as a physician, clinic, surgical center, or other healthcare facility of a		
22	prosthetic device which is sold or purchased with the intention of being		
23	personally used or consumed by individuals pursuant to a prescription by a		
24	physician when the individual is covered by the state of Louisiana Medicaid		
25	insurance program or a Medicaid insurance program administered by a third		
26	party on behalf of the state of Louisiana.
