<u>Proposed law</u> provides every tax benefit and incentive for businesses shall be applied equally to all businesses in a manner that is no less favorable from one business to another. Such benefits and incentives shall be applied automatically to every business without request or action from a business.

<u>Proposed law</u> provides that every small business shall receive the same benefits and incentives as any business who applies to a tax or incentive program administered by any state agency, and receives tax benefits and incentives from such program.
