1	AN ACT
2	To authorize and provide for the transfer of certain state property; to authorize the transfer
3	of certain state property in West Baton Rouge Parish; to provide for the property
4	description; to provide for reservation of mineral rights; to provide terms and
5	conditions; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. The secretary of the Department of Transportation and
8	Development, notwithstanding any other provision of law to the contrary, is hereby
9	authorized, empowered, and directed to convey, transfer, assign, and deliver any
10	interest, excluding mineral rights, the state may have to all or any portion of the
11	following described parcel of property to the Greater Baton Rouge Port Commission:
12	A certain tract of land (Tract 1-B-1), including all improvements
13	located thereon, situated and lying in Sections 95 and 96, Township 7 South,
14	Range 12 East, in the Parish of West Baton Rouge, Louisiana (Southeastern
15	Land District, West of the Mississippi River), containing an acreage of 24.00
16	acres, more or less, particularly described as follows:
17	For a point of reference, commence at the intersection of Northline Road with
18	itself in the inner quadrant approximately 125 feet south of Northline Road to
19	a found 1/2" iron rod, thence proceed on a bearing of South 58° 26' 55" West a
20	distance of 602.47 feet to a set 1/4" square iron bar which is the point of
21	beginning:
22	From said point of beginning, proceed on a bearing of South 74° 08' 11'' East
23	a distance of 710.25 feet to a set 1/4" square iron bar being the Northeast corner
24	of said tract; thence proceed on a bearing of South 36° 32' 33'' West a distance

1	of 1147.90 feet to a calculated point being the Southeast corner of said tract;
2	thence proceed on a bearing of North 72° 00' 08'' West a distance of 1250.00 feet
3	to a calculated point being the Southwest corner of said tract; thence proceed
4	on a bearing of North 58° 26' 55" East a distance of 1395.39 feet to a set 1/4"
5	square iron bar being the Northwest corner of said tract and the point of
б	beginning, containing an acreage of 24.00 acres.
7	Section 2. The secretary of the Department of Transportation and Development
8	is hereby authorized and directed to enter into such agreements, covenants, conditions,
9	and stipulations and to execute such documents as necessary to properly effectuate any
10	conveyance, transfer, assignment, or delivery of title, excluding mineral rights, to the
11	property described in Section (1), and as more specifically described in any such
12	agreements entered into and documents executed by and between the secretary of the
13	Department of Transportation and Development and the Greater Baton Rouge Port
14	Commission, in exchange of consideration proportionate to the appraised value of the
15	property.
