| 9  | Be it enacted by the Legislature of Louisiana:   |
| 10 | Section 1. R.S. 33:4575 and 4575.3(7), (10), and (20)(a) are hereby amended and            |
| 11 | reenacted to read as follows:  |
| 12 | §4575. Northshore Harbor Center District   |
| 13 | There is hereby created the Northshore Harbor Center District. The district                |
| 14 | shall consist of the entire area within Ward Eight and Ward Nine of St. Tammany            |
| 15 | Parish, including any municipalities in those wards. The district is created for the       |
| 16 | purposes set forth in R.S. 33:4575 through 4575.6, and shall be responsible for the        |
| 17 | acquisition, construction, development, maintenance, and operation of an events            |
| 18 | center and the programs and events undertaken therein.                                     |

The board shall have all powers necessary or convenient to effectuate the purposes of the district, including, but not limited to the following rights and powers:

\* \* \*

(7) To accept gifts, grants, and donations of property and money. Title to immovable property acquired shall reside with the Northshore Harbor Center District.

8 \* \* \*

(10) To levy and collect annual taxes, fees, or assessments to the extent permitted by law. Ad valorem taxes may be levied at a rate not to exceed twenty-five mills. Any such tax, fee, or assessment shall be used solely for the acquisition, construction, development, maintenance, repair, reconstruction, refurbishment, renovation, operation, and administration of the facilities of any facility owned, to be owned or operated by the district and the acquisition, construction, repair, or replacement of machinery, equipment, and furnishings, and shall be subject to approval by a majority of the electors of the district voting at an election called by the district and held for that purpose. The taxes, fees, or assessments when levied, shall be from year to year or for such period of years in accordance with the proposition authorizing the imposition of such taxes, fees, or assessments; however, no person and no property shall be exempt from payment of the taxes, fees, or assessments, except to the extent permitted by the provisions of Article VII, Section 20 of the Constitution of Louisiana. The district, upon its own initiative, may call a special election and submit to the qualified electors of the district the question of authorizing the levy of such a tax, fee, or assessment. The district shall call such a special election when requested to do so by petition in writing signed by one-fourth of the qualified electors eligible to vote at such election. These special taxes, fees, or assessments shall be levied, assessed, and collected on the property within the district under the same methods, terms, and conditions at the same time as parish and district taxes are levied, assessed, and collected.
