1	AN ACT
2	To enact R.S. 37:1218.1, relative to immunizations; to provide for the administration of
3	certain immunizations in primary care health professional shortage areas; to provide
4	for the requirements of pharmacists administering the immunization; and to provide
5	for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 37:1218.1 is hereby enacted to read as follows:
8	§1218.1. Administration of certain immunizations in primary care health
9	professional shortage areas
10	A. In any parish designated wholly or in part as a primary care health
11	professional shortage area as set forth under Section 332 of the Public Health
12	Service Act, as determined by the United States Department of Health and
13	Human Services, a pharmacist may administer any of the following vaccines,
14	but only in conformance with the provisions of Subsection B of this Section:
15	(1) Pneumococcal, to any person eighteen years of age or older.
16	(2) Zoster, to any person fifty years of age or older.
17	B. The pharmacist shall administer each immunization in conformance
18	with the most current vaccination administration as set forth by the United
19	States Public Health Service Advisory Committee on Immunization Practices,
20	following guidance published in the Louisiana State Immunization Policies and
21	Procedures Manual, to participate in the program and to be covered by the
22	National Vaccine Injury Compensation Fund.
23	(1)The pharmacist shall report each immunization to the Department of
24	<u>Health and Hospitals, office of public health's Louisiana Immunization Network</u>
25	for Kids Statewide at the time of the immunization or as soon as reasonably
26	practicable thereafter, as this is the official state vaccination record.

1	(2)The pharmacist shall report all adverse events he observes or which
2	are reported to him to the Vaccine Adverse Events Reporting System, the
3	cooperative program of the United States Centers for Disease Control and
4	Prevention and the United States Food and Drug Administration for vaccine
5	safety, or its successor program; and further, the pharmacist shall refer the
6	patient with an adverse event to an immunization for appropriate medical care.
7	(3)The pharmacist shall maintain for at least two years a record of each
8	immunization administered.
9	(4) The pharmacist shall obtain the appropriate credentials to administer
10	immunizations from the board, as administratively defined, prior to
11	administering any such immunization.
12	(5)The pharmacist shall request the name of a patient's primary care
13	provider prior to the administering of any immunization. If the patient
14	identifies such primary care provider to the pharmacist, the pharmacist shall
15	notify the primary care provider, by written or electronic communication, as
16	soon as reasonably possible thereafter that the immunization was administered.
