SUNSET LAW. Re-creates the Louisiana Department of Revenue. (6/30/12)

1	AN ACT
2	To enact R.S. 49:191(6) and to repeal R.S. 49:191(4)(i), relative to the Department of
3	Revenue, including provisions to provide for the re-creation of the Department of
4	Revenue and the statutory entities made a part of the department by law; to provide
5	for the effective termination date for all statutory authority for the existence of such
6	statutory entities; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. Pursuant to R.S. 49:193, the Department of Revenue and the statutory
9	entities made a part of the department by law shall be re-created effective June 30, 2012, and
10	all statutory authority therefor is continued in accordance with the provisions of Part XII of
11	Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.
12	Section 2. Notwithstanding any provision of any previous Act of the legislature, all
13	statutory authority for the existence of the Department of Revenue and the statutory entities
14	made a part of the department as re-created by Section 1 of this Act shall cease as of July 1,
15	2017, pursuant to R.S. 49:191. However, the Department of Revenue may be re-created
16	prior to such date in accordance with the provisions of Part XII of Chapter 1 of Title 49 of
17	the Louisiana Revised Statutes of 1950.

DIGEST

<u>Present law</u> (Sunset) provides that the Dept. of Revenue and all the statutory entities made a part of that department by law shall begin to terminate their operations on July 1, 2012, and that all legislative authority for such entities shall cease as of July 1, 2013, unless the legislature enacts a bill authorizing the re-creation of the department and its statutory entities prior thereto.

<u>Proposed law</u> provides for the general re-creation of the Dept. of Revenue and its statutory entities, effective June 30, 2012, in accordance with the "sunset" law. <u>Proposed law</u> supercedes the provisions of the "sunset" law which set out the procedure for review and re-creation and which require a separate bill to re-create each statutory entity within the department along with additional provisions. <u>Proposed law</u> makes July 1, 2017, the new termination date and termination would begin July 1, 2016, unless the department is re-created again.
