1	AN ACT
2	To enact R.S. 39:248, relative to state government services; to provide for the development
3	of a long term plan to create regional governmental service centers; to provide for
4	the submission of the plan to the Joint Legislative Committee on the Budget for
5	approval; to provide for annual updating of the plan; and to provide for related
6	matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 39:248 is hereby enacted to read as follows:
9	§248. Government service centers
10	A. The division of administration shall develop a long term plan for the
11	creation of regional governmental service centers as a "one-stop shop" for state
12	services. The plan shall:
13	(1) Establish regional boundaries.
14	(2) Identify state services which shall be delivered through the centers.
15	The plan shall note services which are available with full online capability and
16	services which are accessible with the help of skilled specialists.
17	(3) Require that each agency that administers the services identified in
18	Paragraph (2) of this Subsection organize itself structurally for the delivery of
19	services along uniform regional boundaries as established in Paragraph (1) of
20	this Subsection and include such structure and regional delivery of services in
21	its strategic plans.
22	(4) Establish the appropriate number of governmental service centers
23	to be located in each region, depending on regional population, infrastructure,
24	and use demands. Each region shall have one comprehensive center and may
25	have other smaller centers as appropriate.
26	(5)(a) Determine the most cost effective and operationally effective
27	means to develop the regional governmental service centers either by owning

and managing the facilities or by contracting for the operation, management,

2	or leasing of the facilities. The division of administration shall develop an
3	ownership versus lease comparative analysis as well as a life-cycle cost analysis
4	as deemed appropriate to assist in making the determination. Such findings
5	shall be presented to the Joint Legislative Committee on the Budget along with
6	the long term plan.
7	(b) If it is determined that outsourcing property management services
8	is the most cost effective means for the development and establishment of
9	regional governmental service centers, the division of administration shall have
10	the authority to allow for the use of existing state owned facilities by formal
11	agreement with the outsourced property management company provided the
12	agreement establishes a fair market price for the use of state properties by the
13	management company or companies. The division of administration shall have
14	the authority to include operations and maintenance in the property
15	management contracts.
16	(6) Provide a long term plan and strategy to implement consolidated
17	services to be delivered in the regional governmental service center.
18	(7) Provide a process for addressing surplus property and reduction in
19	personnel as services are consolidated into the centers.
20	B. As part of the process for the development of the long term plan
21	described in Subsection A of this Section, the division of administration shall
22	conduct a public hearing to receive input from local residents in each of the
23	proposed regions.
24	C.(1) On or before March 15, 2011, the division shall submit the report
25	detailing the status of the long term plan or status on the development of such
26	as described in Subsection A of this Section to the Joint Legislative Committee
27	on the Budget for approval.
28	(2) A copy of the report shall also be submitted to the Commission on
29	Streamlining Government.
30	(3) Annually, beginning on March 1, 2012, the division shall issue a

report to the Joint Legislative Committee on the Budget detailing the status of

2 the development and implementation of the long term plan until such time as 3 the centers are fully operational. The update shall indicate progress in the 4 establishment of the centers and the services provided as well as obstacles to further development and implementation of a consolidated state service delivery 5 system. The updates shall also include overall quality of service measurements 6 7 as provided by the agencies through the Louisiana Governmental Performance and Accountability System (LaPAS) and any efficiencies and cost savings which 8 9 may be realized. 10 D. After approval of the long term plan by the Joint Legislative Committee on the Budget, the commissioner of administration shall not approve 11 12 a new lease or the renewal of any lease or approve a purchase for agency 13 housing space that is in conflict with the long term plan without approval of the Joint Legislative Committee on the Budget. For state-owned property used for 14 15 the delivery of state services that is not designated as a center, the commissioner may require that such property be sold once services are transferred to the 16 17 center. 18 E.
