Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 47:501(C)(1) and (2) are hereby amended and reenacted and R.S. 47:501(D) is hereby enacted to read as follows:

§501. Owner to secure registration

* * *

C.(1) An individual applying for initial registration of a motor vehicle, trailer, semitrailer, or other vehicle intended to be operated upon the public highways of this state shall provide a current and valid photo identification which includes the owner's full legal name and license number or identification card number issued in this state; or another state, or by the United States military. An individual applying for initial registration through the mail shall include a copy of a current and valid photo identification which includes the owner's full legal name and license number or identification card number issued in this state; or another state, or by the United States military with his application. If the individual does not possess any of the credentials specified in this Paragraph, the individual shall certify in writing that he does not possess any of the credentials specified in this Paragraph on a form approved by the Department of Public Safety and Corrections. Any application which is not accompanied by a copy of the credential or the

certification required by this Paragraph shall not be accepted or processed by

The individual's full legal name and the 3 number on the any identification provided shall be placed on the application. 4 (2) An individual applying for the first renewal of registration of a motor vehicle, trailer, semitrailer, or other vehicle intended to be operated upon the public 5 highways of this state shall provide a current and valid photo identification which 6 7 includes the owner's full legal name and license number or identification card number issued in this state, or by the United States military. An 8 9 individual applying for a first renewal through the mail shall include a copy of a 10 current and valid photo identification which includes the owner's full legal name and 11 license number or identification card number issued in this state, another state, or by 12 the United States military with his application. The individual's full legal name and 13 the number on the identification provided shall be placed on the application. 14 D.
