BESE. Constitutional amendment to provide for the membership of one student on the State Board of Elementary and Secondary Education. (2/3 - CA13s1(A))

A JOINT RESOLUTION

Proposing to amend Article VIII, Section 8(B) of the Constitution of Louisiana, relative to the membership of certain constitutionally-created boards; to provide for student membership on the State Board of Elementary and Secondary Education; and to specify an election for submission of the proposition to electors and provide a ballot proposition.

Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members

Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members elected to each house concurring, that there shall be submitted to the electors of the state, for their approval or rejection in the manner provided by law, a proposal to amend Article VIII, Section 8(B) of the Constitution of Louisiana, to read as follows:

§8. Boards; Membership; Compensation; Congressional District Member

12 * * *

(B) Student Membership. The legislature may provide for the membership of one student on the boards created by Sections 3, 5, 6 and 7 of this Article. The term of a student member shall not exceed one year, and no student member shall be eligible to succeed himself. A student member shall have all of the privileges and rights of other board members.

<u>Present constitution</u> provides that the legislature may provide by law for student membership on the Board of Regents and certain public postsecondary education management boards.

<u>Proposed constitutional amendment</u> authorizes the legislature to provide by law for the membership of one student on the State Board of Elementary and Secondary Education.

Specifies submission of the amendment to the voters at the statewide election to be held on November 3, 2020.
