2	To enact R.S. 37:2156.3, relative to the Louisiana State Licensing Board for Contractors; to
3	provide relative to solar energy equipment and systems; to provide for examinations;
4	to provide for procedures, terms, and conditions; to provide for the adoption of rules;
5	and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 37:2156.3 is hereby enacted to read as follows:
8	§2156.3. Installation of solar energy equipment and systems
9	A. No licensed contractor shall install solar energy equipment or solar
10	energy systems on or after February 1, 2015, unless he is in compliance with the
11	provisions of this Section and any rules adopted by the board in accordance
12	with the provisions of this Section.
13	B.(1) Notwithstanding any provision of law to the contrary, no later than
14	January 1, 2015, the board shall adopt rules in accordance with the
15	Administrative Procedure Act regulating the installation of solar energy
16	equipment or solar energy systems by licensed contractors. Such rules shall, at
17	a minimum, include the requirement of passage of a separate written
18	examination that evidences the contractor's knowledge and understanding of
19	best practices as related to the installation and maintenance of solar energy
20	equipment or solar energy systems by any contractor who does not hold a
21	current Solar PV Installer certification for solar electric systems, or a current
22	Solar Heating Installer certification for solar thermal hot water systems as
23	issued by the North American Board of Certified Energy Practitioners.
24	(2) Any contractor licensed in this state as of August 1, 2014, holding

1	the major classification of Building Construction, Electrical Work (Statewide),
2	or Mechanical Work (Statewide), shall be deemed to have met the examination
3	requirement pursuant to this Subsection.
4	C. Contractors applying for the classification of Solar Energy
5	Equipment, shall, in addition to all other application or licensing requirements,
6	meet the following requirements prior to issuance of this classification:
7	(1) Hold one or more of the following major classifications:
8	(a) Building Construction.
9	(b) Electrical Work.
10	(c) Mechanical Work.
11	(d) Residential Building Contractor.
12	(2) Complete training in the design of solar energy systems by an entity
13	and course approved by the board.
14	D. Any work performed to connect wiring or hookups for any
15	photovoltaic panel or system wherein the panel or system is of a value, including
16	labor, materials, rentals, and all direct and indirect project expenses, of ten
17	thousand dollars or more shall be performed only by a contractor or
18	subcontractor who holds the classification of Electrical Work or who may
19	perform electrical work pursuant to the provisions of R.S. 37:2156.2(B).
20	E. Any work performed to connect piping or equipment for any solar
21	thermal system wherein the system is of a value, including labor, materials,
22	rentals, and all direct and indirect project expenses, of ten thousand dollars or
23	more shall be performed only by a contractor or subcontractor who holds the
24	classification of Mechanical Work or who may perform mechanical work
25	pursuant to the provisions of R.S. 37:2156.2(B).
26	F. The provisions of this Section shall be applicable to entities engaging
27	in the business of selling, leasing, installing, servicing, or monitoring solar
28	energy equipment. Nothing in this Section shall be construed to impose civil or
29	criminal liability on homeowners or on any third party whose involvement is
30	financing to the homeowner, financing for installation, or purchasing the tax

1	credits described in thi	is Section from any homeowner or contractor. Entities	
2	engaged in the business of arranging agreements for the lease or sale of solar		
3	energy systems or acquiring customers for financing entities shall not be exempt		
1	from the provisions of this Section.
