WORKERS' COMPENSATION. Provides for a credit for compensation benefits payable to a professional athlete who receives payment pursuant to the provisions, including injury provisions, contained in a contract or collective bargaining agreement. (gov sig)

AN ACT

2	To enact R.S. 23:1225(D), relative to workers' compensation benefits to professional
3	athletes; to provide for a reduction of offset of certain benefits; and to provide for
4	related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 23:1225(D) is hereby enacted to read as follows:
7	D. The compensation benefits payable to a professional athlete under
8	any provision of this Chapter shall be reduced or offset by an amount equal to
9	the total amount of benefits, wages, or other type of payment, including, but not
10	limited to the listing in this Subsection, on a dollar-for-dollar basis and not
11	merely on a week-to-week basis, if a professional athlete receives payment or
12	remuneration of any type from any of the following:
13	(1) Any wages or benefits payable or paid to the athlete.
14	(2) A collective bargaining agreement.
15	(3) A contract of hire of any type.
16	(4) Any type of severance pay.
17	(5) Any type of injured reserve pay.

1	(6) Any type of termination pay.
2	(7) Any grievance or settlement pay.
3	(8) Any workers' compensation benefit of any type.
4	(9) Any other payment made to the professional athlete by the employer
5	pursuant to any and all contracts of agreement.
6	Section 2. This Act shall become effective upon signature by the governor or, if not
7	signed by the governor, upon expiration of the time for bills to become law without signature
8	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
9	vetoed by the governor and subsequently approved by the legislature, this Act shall become
10	effective on the day following such approval.

## **DIGEST**

<u>Present law</u> provides for no reduction or offset of workers' compensation benefits due to a professional athlete based upon other monies paid due to a contract or a collective bargaining agreement.

<u>Proposed law</u> provides for a dollar-for-dollar reduction of workers' compensation benefits payable to a professional athlete, regardless of the type of payment.

<u>Proposed law</u> lists the following possible sources of such payment to the professional athlete:

- 1. Any wages or benefits.
- 2. A collective bargaining agreement.
- 3. A contract.
- 4. Severance pay.
- 5. Injured reserve pay.
- 6. Termination pay.
- 7. Grievance or settlement pay.
- 8. Workers' compensation benefits.
- 9. Any other payment made to the professional athlete.

Effective upon signature of the governor.
