1	AN ACT
2	To enact R.S. 47:463.196 and 463.197, relative to motor vehicles; to provide for the
3	"Autism" special prestige license plate; to provide for the "Louisiana Motor
4	Transport Association" special prestige license plate; to provide for the creation,
5	issuance, and design of such plates; to authorize adoption of rules and regulations;
6	to provide an effective date; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 47:463.196 and 463.197 are hereby enacted to read as follows:
9	§463.196. Special prestige license plate; "Autism"
10	A. The deputy secretary of the Department of Public Safety and
11	Corrections, public safety services, shall establish a special prestige motor
12	vehicle license plate to be known as the "Autism" plate. The plate shall be
13	restricted to use on passenger cars, pickup trucks, motorcycles, recreational
14	vehicles, and vans.
15	B. The deputy secretary shall work in conjunction with the Autism
16	Society-Louisiana State Chapter, Inc. (LSAC) to select the color and design of
17	the plate, provided it is in compliance with R.S. 47:463(A)(3). The design shall
18	include the word "Autism".
19	C. The special prestige license plate shall be issued, upon application, to
20	any resident of Louisiana in the same manner as any other motor vehicle license
21	plate.
22	D. The department shall collect an annual royalty fee of twenty-five
23	dollars that shall be disbursed in accordance with Subsection E of this Section.
24	This royalty fee shall be in addition to the standard motor vehicle license tax

2	handling fee of three dollars and fifty cents for each plate to be retained by the

4	E. The annual royalty fee shall be collected by the department and
5	forwarded to the Autism Society-Louisiana State Chapter, Inc. (LSAC).
6	F. The deputy secretary shall adopt rules and regulations as are

9	Association"
10	A. The deputy secretary of the Department of Public Safety and
11	Corrections shall establish a special prestige motor vehicle license plate to be
12	known as the "Louisiana Motor Transport Association" plate. The license plate
13	shall be available for use on any personal motor vehicle or commercial vehicle
14	under sixteen thousand pounds which does not require apportioned plates as
15	established by the International Registration Plan.
16	B. The secretary shall work in conjunction with the executive director
17	of the Louisiana Motor Transport Association, Inc. to select the color and
18	design of the plate, provided it is in compliance with R.S. 47:463(A)(3).
19	C. The special prestige license plate shall be issued, upon application, to
20	any citizen of Louisiana in the same manner as any other motor vehicle license
21	plate.
22	D. The department shall collect an annual royalty fee of twenty-five
23	dollars that shall be disbursed in accordance with Subsection E of this Section.
24	This fee shall be in addition to the standard motor vehicle license tax imposed
25	by Article VII, Section 5 of the Constitution of Louisiana, and a handling fee of
26	three dollars and fifty cents for each plate to be retained by the department to
27	offset a portion of administrative costs.
28	E. The annual royalty fee shall be collected by the department and
29	forwarded to the Louisiana Motor Transport Association, Education
30	Foundation.

1	F. The deputy secretary shall promulgate and adopt rules and
2	regulations as are necessary to implement the provisions of this Section.
3	Section 2. This Act shall become effective on January 1, 2019.
