1	AN ACT
2	To amend and reenact the introductory paragraph of R.S. 33:2740.67(C)(1),
3	2740.67(C)(1)(a) and (f) through (i) and (k), (2), and (3) and to repeal R.S.
4	33:2740.67(C)(1)(l), relative to the Baton Rouge North Economic Development
5	District; to provide relative to the boundaries of the district; to provide for the
6	governance of the district; and to provide for related matters.
7	Notice of intention to introduce this Act has been published.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. The introductory paragraph of R.S. 33:2740.67(C)(1), 2740.67(C)(1)(a)
10	and (f) through (i) and (k), (2), and (3) are hereby amended and reenacted to read as follows:
11	§2740.67. Baton Rouge North Economic Development District

13	C. Governance. (1) In order to provide for the orderly planning, development,
14	acquisition, construction, and effectuation of the services, improvements, and
15	facilities to be furnished by the district and to provide for the representation in the
16	affairs of the district of those persons and interests immediately concerned with and
17	affected by the purposes and development of the district, the district shall be
18	managed by a thirteen <b><u>nine</u></b> -member board of commissioners, referred to in this
19	Section as the "board". The board shall be comprised of members as follows:
20	(a) One member shall be appointed by the state representative for House
21	District No. 29, one of whom who shall be a representative of the business
22	community, on a rotating basis beginning in 2022 and every other year
23	thereafter.

3	Section 2. R.S. $33:2740.67(C)(1)(1)$ is hereby repealed.
4	Section 3. This Act shall become effective upon signature by the governor or, if not
5	signed by the governor, upon expiration of the time for bills to become law without signature
6	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
7	vetoed by the governor and subsequently approved by the legislature, this Act shall become
8	effective on the day following such approval.
