| 10 | A. There shall be allowed a one-time refundable credit against Louisiana |
| 11 | income tax for a portion of the state license or permit fees imposed by the |
| 12 | commissioner of alcohol and tobacco control and paid by the owners or |
| 13 | operators of restaurant establishments and establishments licensed to sell or |
| 14 | serve alcoholic beverages for consumption on their premises by paying |
| 15 | customers. |
| 16 | B. (1) The amount of the credit shall equal the amount of the annual state |
| 17 | license or permit fee for calendar year 2020 attributable to any calendar month, |
| 18 | or fraction thereof, during 2020 that the permit holder was required to |
| 19 | temporarily close operations pursuant to Proclamation Number 30 JBE 2020, |
| 20 | or any subsequent proclamation declaring the existence of a statewide |
| 21 | COVID-19 public health emergency. |
| 22 | (2) The credit authorized pursuant to the provisions of this Section shall |
| 23 | apply to licenses or permits issued on a two-year basis if any part of the license |
| 24 | or permit authorized the business to be operational during calendar year 2020 |
| 25 | and the amount of the credit shall be determined as provided in Paragraph (1) |
