AN ACT

2	To enact Chapter 10-D of Title 46 of the Louisiana Revised Statutes of 1950, to be
3	comprised of R.S. 46:1191 through 1196, relative to a healthcare service district
4	within Department of Health and Hospitals' Region IV; to provide such authority to
5	create the healthcare service district; to provide for the governing board for the
6	healthcare service district; to provide for the membership of the governing board and
7	for the appointment, terms, and compensation of the board; and to provide for related
8	matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Chapter 10-D of Title 46 of the Louisiana Revised Statutes of 1950,
11	comprised of R.S. 46:1191 through 1196 is hereby enacted to read as follows:
12	CHAPTER 10-D. HEALTHCARE SERVICE DISTRICT - DEPARTMENT
13	OF HEALTH AND HOSPITALS' REGION IV
14	§1191. Legislative intent
15	It is the intent of the legislature to allow the governing authority of the
16	parish or the governing authorities of parishes that are located within the
17	Department of Health and Hospitals' Region IV, upon their own initiative, to
18	form and create a healthcare service district to support the provision of
19	inpatient and outpatient healthcare services within the Department of Health
20	and Hospitals' Region IV.
21	§1192. Definitions
22	As used in this Chapter and unless the context clearly requires
23	otherwise:

1	(1)" Department" means the Department of Health and Hospitals.
2	(2) "District" means the healthcare service district authorized in this
3	Chapter.
4	(3) "Governing board" means the governing board of the healthcare
5	service district.
6	(4) "Secretary" means the secretary of the Department of Health and
7	Hospitals.
8	§1193. Authority
9	The governing authority of a parish or the governing authorities of the
10	parishes that are located within the department's Region IV, upon their own
11	initiative, are hereby authorized and empowered to form and create a
12	healthcare service district.
13	<u>§1194. Purpose</u>
14	The purpose of the healthcare service district and the governing board
15	created under the provisions of this Chapter shall be:
16	(1)To identify local public sources of revenue or expenditure that may
17	be used by the department as state match to draw down federal matching funds
18	for the provision of healthcare services for the low income and uninsured
19	population of the district. Notwithstanding any other provision of law to the
20	contrary, the district or governing board shall have no authority or governance
21	of the hospital service districts and shall have no authority to collect or cause to
22	be collected any hospital service district monies, funds, or assets.
23	(2) To participate, so far as circumstances may warrant, in any activity
24	designed and conducted to promote the general health of the community.
25	(3) To promote and support graduate medical education activities in the
26	respective communities.
27	(4) To cooperate with other institutions and agencies engaged in
28	providing hospital and outpatient health services to residents of the district for
29	the purpose of improving access to care for residents of the district.
30	§1195. Powers and duties of governing board

1	A. In addition to the duties defined elsewhere in this Chapter, the
2	governing board shall have the duty and authority:
3	(1) To represent the public interest in supporting healthcare services in
4	the district.
5	(2) To advise on issues concerning the provision of healthcare services
6	for the low income and uninsured population of the district.
7	(3) To conduct public hearings and share public input on the
8	community's priorities for the provision of healthcare services in the district.
9	(4) To appoint the necessary standing and special committees that may
10	be necessary to carry out the purposes of this Chapter.
11	(5) To enter into contracts, agreements, or cooperative endeavors with
12	the state and its political subdivisions and with any public or private
13	association, corporation, business entity or person to promote the public
14	purposes of the district.
15	B. The secretary of the department shall review each such agreement,
16	including a plan for the use of state Medicaid and disproportionate share
17	dollars. If the secretary finds that the agreement and plans are sufficient to
18	support medical care for low income and uninsured population of the district
19	and the funds are eligible for federal matching funds to be reimbursed, he shall
20	verify that finding to the governing board.
21	C. The governing board shall collect or cause to be collected all public
22	monies identified by the district as available for the purpose of serving as state
23	match for federal matching funds to ensure the provision of healthcare services
24	delivered for the low income and uninsured population of the district.
25	D. The department shall make available for reimbursement these local
26	and federally matched funds to the designated providers in the district to ensure
27	the continued provision of healthcare services for the low income and uninsured
28	population of the district.
29	E. Neither the division of administration nor the department shall
30	displace, replace, or supplant state appropriations from the state general fund

1	or other state funds designated for the district.
2	F. The governing board shall submit any reports or information related
3	to the healthcare service district to the secretary of the department or the
4	Senate and House committees on health and welfare upon request of the
5	secretary or the chairman of either committee.
6	§1196. Governing board; membership; appointment; terms; compensation
7	A.(1) For a district created pursuant to this Chapter, the district shall be
8	governed by a governing board.
9	(2)The governing board shall be comprised of the following members:
10	(a) The president of each parish governing authority within the
11	department's Region IV, or his designee.
12	(b) The secretary of the Department of Health and Hospitals, or his
13	designee.
14	(c) The executive director of the Louisiana Hospital Association, or his
15	designee.
16	(d) The executive director of the Greater Lafayette Chamber of
17	Commerce, or his designee.
18	(e) The hospital administrator for University Medical Center, or his
19	designee.
20	B. All appointees shall serve terms of three years. No board member
21	shall serve more than two three-year consecutive terms.
22	C. A vacancy on a governing board shall be filled in the same manner as
23	required for the original appointment.
24	D. Each governing board member shall serve without compensation but
25	shall be reimbursed for expenses and mileage at the same rate set by the
26	division of administration for state employees for each day in actual attendance
27	at governing board meetings or for representing the governing board in an
28	official governing board-approved activity.
29	E. The chairman shall be elected by a majority vote of the governing
30	board. The term of the chairman shall be established under the governing

2	F. The governing board shall adopt bylaws to provide for its governance
3	within ninety days of being established. Such bylaws shall include but not be
4	limited to:
5	(1) Procedures for the election of governing board officers, including
6	terms of office and methods and grounds for removal. Governing board officers
7	shall include, at a minimum, a chairman, treasurer, and secretary.
8	(2) Procedures and grounds for the removal of any governing board
9	member. Grounds for removal shall include the conviction of a felony. Grounds
10	for removal may include failure to meet board attendance requirements, as
11	provided in the bylaws.
12	G. All governing board members of the district shall be subject to the
13	Code of Governmental Ethics. No member of the governing board or of his
14	immediate family shall own or have any interest in any public or private
15	organization, business, company, or entity conducting business of any kind with
16	the district. The prohibition provided for in this Subsection shall not prohibit
17	members of the governing board from having contracts or employment
18	agreements with healthcare institutions or organizations whose purpose is
19	directly related to health care.
