WHEREAS, Andy was born December 5, 1979, in Bristol, Pennsylvania, to Philip

WHEREAS, a longtime member of Jesus the Good Shepherd Catholic Church where he served as president of the parish council and was a member of ACTS; he was humble and always put the Lord first; and

WHEREAS, Andy received a Bachelor of Business Administration from the University of Louisiana at Monroe and was the owner and operator of Trahan Solutions; he was also a member of Delta Sigma Phi Fraternity; and

WHEREAS, he was a music lover and never missed an opportunity to play the drums; he also loved sports and was a natural on the tennis and basketball courts, and one of his favorite places to visit was New Orleans as a dedicated member of the "Who Dat Nation"; and

WHEREAS, Andy was diagnosed with stage four lung cancer over seven years ago and made it his life mission to better understand the disease so that he could help others; and

WHEREAS, he was a fierce lung cancer advocate and mentor and a charter member of ALK Positive, a patient/caregiver advocacy and fundraising organization; he attended numerous lung cancer conferences nationwide and lobbied on Capitol Hill; he originated a proposal for a Lung Cancer Awareness license plate which was enacted in 2016 as Act 296 after being introduced as House Bill 1010 by Representative Philip R. Devillier; and

WHEREAS, Andy tirelessly fought the stigma that lung cancer is always linked to
