1	A RESOLUTION
2	To commend Chris Joseph LeBlanc upon his retirement after a long and distinguished career
3	as a member of the United States Army with twenty-four years of service to his
4	country, having achieved the rank of Major, and as a financial advisor following his
5	retirement from the military.
6	WHEREAS, Chris Joseph LeBlanc was born in Klotzville, Louisiana, on July 17,
7	1950, to Marilyn and Joseph "Jo-Jo" LeBlanc, and is the brother of Diane, Debbie, and Lyn
8	LeBlanc; and
9	WHEREAS, Chris is the husband of Jill Bergeret LeBlanc, originally of New
10	Orleans, whom he met and married while he was an ROTC instructor at Tulane University
11	and Loyola University, New Orleans, and the University of New Orleans, and both have
12	been residents of Leavenworth, Kansas, since 1985; and
13	WHEREAS, Chris is the proud father of two sons, Paul and Dan, both of whom
14	chose to further their formal education at Louisiana universities; Paul at Nicholls State
15	University and Dan at Louisiana State University at Baton Rouge, where he was a member
16	of the ROTC Program; and
17	WHEREAS, as a young boy Chris was a dedicated altar server for St. Elizabeth
18	Catholic Church Parish in Paincourtville, Louisiana; and

1	WHEREAS, Chris is an honor graduate of St. Elizabeth Catholic School in
2	Paincourtville, Louisiana, and Assumption High School in Napoleonville, Louisiana, and
3	was named the 2009-10 Distinguished Graduate of St. Elizabeth School by the Baton Rouge
4	Diocese; and
5	WHEREAS, Chris attended the United States Military Academy at West Point from
6	1968 through 1972 on an honor scholarship from the academy, graduating in 1972 and
7	attending U.S. Army Airborne School at Fort Benning, Georgia, that year; and
8	WHEREAS, Major LeBlanc attended the Armor Officer Basic Course and Armor
9	Officer Motor Course at Ft. Knox, Kentucky, from 1972 through 1973; and
10	WHEREAS, Major LeBlanc served as Mortar and Tank Platoon Leader, Tank
11	Company Executive Officer, 1 st Battalion 73 rd Armor Division at Camp Casey, Korea, from
12	1973 through 1974; and
13	WHEREAS, Major LeBlanc served as Scout Platoon Leader, Company Executive
14	Officer, 2 nd Battalion 67 th Armored Division at Ft. Hood, Texas, from 1974 through 1975;
15	and
16	WHEREAS, Major LeBlanc served as S-3 Air, Company Commander, Battalion
17	Motor Officer, 2 nd Battalion, 66th Armor Division, at Ft. Hood, Texas, from 1975 through
18	1978, with a six-month deployment to Grafenwohr, Germany, in 1975 and 1977; and
19	WHEREAS, Major LeBlanc served as an ROTC instructor at Tulane University and
20	Loyola University, New Orleans, from 1978 through 1982; and
21	WHEREAS, Major LeBlanc completed the Defense Information Officer Course at
22	Ft. Benjamin Harrison, Indiana, in 1982; and
23	WHEREAS, Major LeBlanc served as the Public Affairs Officer, 2 nd Armored
24	Division Forward, from 1982 through 1984, and S-3, 2 nd Battalion 66 th Armor Division, from
25	1984 through 1985, at Garlstedt, Germany; and
26	WHEREAS, Major LeBlanc served as an instructor at the Command and General
27	Staff College at Ft. Leavenworth, Kansas, from 1985 through 1988, and served as the
28	Managing Editor of Military Review at Ft. Leavenworth, Kansas, from 1988 through 1992;

30	WHEREAS, Major LeBlanc retired from active duty in June 1992 after a successful

1	and distinguished twenty-four year career in the United States Army; and
2	WHEREAS, Chris served as Financial Advisor at IDS Financial Services, Overland
3	Park, Kansas, from 1992 through 1993; Financial Advisor and District Manager,
4	IDS/American Express Financial Advisors, Overland Park and Leavenworth, Kansas, from
5	1993 through 2002; Interim Field Vice President, American Express Financial Advisors,
6	Overland Park, Kansas, from 1995 through 1996; Financial Advisor and Branch Manager,
7	Ameriprise Financial Advisors, Leavenworth, Kansas, from 2003 through 2008; and
8	Financial Advisor, Ameriprise Financial Advisors, Leavenworth, Kansas, until 2013; and
9	WHEREAS, Chris retired from Ameriprise Financial Advisors in April 2013; and
10	WHEREAS, Chris enjoys in his leisure time annual trips to Belize to celebrate "Jerry
11	Jeff Walker's Annual Birthday Bash!"; and
12	WHEREAS, Chris also enjoys all LSU sports and is a "die hard" Tiger baseball fan,
13	and always is a spectator in Omaha when the Tigers play for the National Championship.
14	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
