9	Groundwater Conservation District (R.S. 38:3071); the Atchafalaya Basin Levee District
10	(R.S. 38:291(A)); the Louisiana Capital Area Economic Development Alliance Film
11	Commission (R.S. 33:9039.81); the Capital Area Human Services District (R.S. 28:901);
12	the Mississippi River Road Commission (R.S. 25:1251); the Atchafalaya Trace Commission
13	(R.S. 25:1222); the Tri-Parish Juvenile Justice District (R.S. 15:1096); the Delta
14	Development Initiative (R.S. 3:333); and State Area No. 5 of the State Soil and Water
15	Conservation Commission (R.S. 3:1204); and
16	WHEREAS, the entirety of Pointe Coupee Parish is included in the election
17	jurisdiction of several offices, including Supreme Court District 5 (R.S. 13:101(5)); the first
18	election section of the first district of the First Circuit Court of Appeal (R.S. 13:312(1)(b));
