WHEREAS, he would marry Kaanan Anderson in Jacksonville, North Carolina, in 1998, and they began raising a family during the periods he and his unit were not deployed overseas; and

WHEREAS, SSG. Mackey felt truly blessed for his loving wife, Kaanan, and his five children, Alexis, Jonathan, Chloe, Aiden, and Hana, who all gave him great joy and fulfillment; and

WHEREAS, SSG. Mackey served his country bravely in Operation Enduring Freedom/Noble Eagle in 2004, and Operation Iraqi Freedom from October of 2008 to October of 2009; and

WHEREAS, SSG. Mackey was enrolled in classes at Indian Hills Community College after his return from combat, taking instructions in aviation in order to fulfill a lifelong passion for flying; and

WHEREAS, SSG. Mackey was thirty-three years old and riding the motorcycle that gave him that feeling of flying when he was involved in a traffic accident that took his life on July 28, 2010, while his wife, Kaanan, held him in her arms at Mercy Hospital in Des Moines, Iowa, in a final, loving embrace; and

Mackey's awards and decorations include the Meritorious Service Medal, the Army Commendation Medal, the Army Achievement Medal with oakleaf cluster, the Army Good Conduct Medal, the Marine Corps Good Conduct Medal, the Army Reserve Components Achievement Medal, the National Defense Medal with bronze service star, Iraqi Campaign Medal with bronze service star, Global War on Terrorism Service Medal, Armed Forces Reserve Medal with Mobilization Device, Noncommissioned Officer Professional Development Ribbon, Army Service Ribbon, Overseas Service Ribbon, Sea Service Deployment Ribbon, and Driver and Mechanic Badge with Wheeled Device.
