By Ms. Marty Walz of Boston, petition (accompanied by bill, House, No. 01170) of Stephen Kulik and others relative to prohibiting the sale, installation and disposal of mercury thermostats. Joint Committee on Environment, Natural Resources and Agriculture.

### The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act prohibiting the sale, installation and disposal of mercury thermostats.

Whereas, the deferred operation of this act would tend to defeat its purpose, which is forthwith to reduce the presence of mercury in the environment, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public safety.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. The General Laws are hereby a mended by inserting after Chapter 25C the
- 2 following chapter:-
- 3 Chapter 25D.
- 4 Section 1. Short title. This act shall be known and may be cited as the Mercury-Free Thermostat
- 5 Act.
- 6 Section 2. Legislative findings. The General Court finds and declares as follows:

- 7 (1) Waterways throughout this Commonwealth have been placed under fish consumption
- 8 advisory warnings due to high levels of mercury contamination.
- 9 (2) Human exposure to mercury from thermostats is primarily through improper disposal of
- 10 items in landfills or through incineration.
- 11 (3) Mercury thermostats represent the largest amount of mercury in ordinary household products.
- 12 A single mercury thermostat contains between three and five grams of mercury.
- 13 According to the Environmental Protection Agency's 2002 estimates, each year about six to eight
- 14 tons of mercury from discarded thermostats end up in solid waste facilities and between one and
- 15 two tons are released into the air.
- 16 (4) Electronic programmable thermostats that do not contain mercury are readily available and
- 17 can save consumers considerable money in energy costs when used properly. Snap switch
- 18 thermostats that function like mercury thermostats, but contain no mercury, are also available.
- 19 (5) The Commonwealth supports shared responsibility for all stakeholders including
- 20 manufacturers, wholesalers, after market users, local and state governments working to resolve
- 21 those issues and efforts to reduce mercury entering the atmosphere and water supply from all
- 22 sources in the most cooperative and cost-effective means available.
- 23 (6) The nonprofit Thermostat Recycling Corporation (TRC), created and supported by thermostat
- 24 manufacturers, runs a voluntary program designed to collect mercury thermostats from
- 25 wholesalers. The TRC program has been operating in this Commonwealth since 2000 and has
- 26 recycled almost 17,500 thermostats, thereby diverting more than 140 pounds of mercury in eight
- 27 years in Massachusetts. This Commonwealth has been a consistent leader in environmental

- 28 legislation and formal implementation and participation will only increase the amount of diverted
- 29 mercury.
- 30 (7) It is in the public interest to increase the scope and effectiveness of mercury thermostat
- 31 collection programs through promotion and expansion of recycling efforts and banning the sale,
- 32 installation and disposal of mercury thermostats in this Commonwealth.
- 33 Section 3. Definitions. The following words and phrases when used in this act shall have the
- 34 meanings given to them in this section unless the context clearly indicates otherwise:
- 35 "After-Market User", a business that the Department of Energy Resources determines is
- 36 primarily engaged in the installation or removal of heating, ventilation and air conditioning
- 37 components.
- 38 "Department", the Department of Energy Resources of the Commonwealth.
- 39 "Manufacturer", the owner of a brand name on a thermostat.
- 40 "Mercury thermostat", a product or device that contains mercury or a mercury compound and is
- 41 used to sense and control room temperature through communication with heating, ventilating or
- 42 air-conditioning equipment. The term does not include such product or device used to sense and
- 43 control temperature as part of a manufacturing process.
- 44 "Retailer", a business that sells thermostats of any kind directly to homeowners, other
- 45 nonprofessionals or contractors through any selling or distribution mechanism, including, but not
- 46 limited to, sales using the Internet or catalogs. A retailer may also be a wholesaler if the retailer
- 47 meets the definition of wholesaler.

- 48 "Wholesaler", a business that the Department of Energy Resources determines is primarily
- 49 engaged in the distribution and wholesale selling of large quantities of heating, ventilation and
- 50 air conditioning components to contractors who install heating, ventilation and air conditioning
- 51 components.
- 52 Section 4. Prohibiting disposal of mercury thermostats. (a) General rule.--No person,
- 53 municipality or operator of a solid waste treatment, processing or disposal facility or after-market
- 54 user shall knowingly dispose, permit the disposal of, or send to a resource recovery facility for
- 55 processing, a mercury thermostat from which the mercury has not been removed for reuse,
- 56 recycling or other methods approved by the department.
- 57 (b) Exception.--No operator of a solid waste treatment, processing or disposal facility shall be
- 58 found to have knowingly disposed of a mercury thermostat if the facility has notified customers
- 59 of the ban in writing and posted signs at the facility clearly noting the prohibition.
- 60 (c) Construction.--This subsection shall not be construed to affect prior existing laws, rules or
- 61 regulations more stringent than the provisions under subsection (a) governing the disposal of
- 62 mercury, mercury thermostats and other products containing mercury.
- 63 Section 5. Collection and recycling programs. (a) Manufacturer programs.--
- 64 (1) Each manufacturer of mercury thermostats that have been sold in this Commonwealth shall,
- 65 individually or collectively, establish and maintain a collection and recycling program for out-of-
- 66 service mercury thermostats from wholesalers, contractors, service technicians, after-market
- 67 users and homeowners.
- 68 (2) The program shall be developed in a manner that ensures to the maximum extent that:

- 69 (i) There is no direct cost to contractors, service technicians or homeowners for participating in
- 70 the program, except that wholesalers and contractors and may be assessed a nominal
- 71 administrative fee to offset the cost of each collection bin for each collection location for out-of-
- 72 service thermostats.
- 73 (ii) Information and education on proper management and recycling of mercury thermostats are
- 74 provided to contractors, service technicians, wholesalers, retailers, institutions and homeowners
- 75 to encourage the return of out-of-service thermostats at established recycling collection points.
- 76 (iii) The purchase of mercury-free programmable thermostats qualified by the Environmental
- 77 Protection Agency's Energy Star program as replacements for mercury thermostats is
- 78 encouraged.
- 79 (iv) The handling and recycling of mercury thermostats is accomplished in a manner compliant
- 80 with section 4 and all other applicable Federal, State and local requirements.
- 81 (b) Wholesaler and contractor participation.--
- 82 (1) Beginning one year after the effective date of this section, except as provided for in
- 83 paragraph (4), a wholesaler or contractor may not sell a thermostat in this Commonwealth unless
- 84 the wholesaler or contractor acts as a collection site for thermostats that contain mercury.
- 85 (2) The Department may require that a wholesaler or contractor must meet the requirements of
- 86 this subsection by participating as a collection site in a manufacturer collection program as
- 87 described under subsection (a) or by collecting thermostats that contain mercury and managing
- 88 the collected thermostats in accordance with applicable Federal and State universal waste rules.

- 89 (3) A wholesaler acting as a collection site shall provide visible signage at the site about the collection and recycling of mercury thermostats.
- 91 (4) A wholesaler or contractor that sells thermostats but chooses not to act as a collection site or
- 92 participate in a manufacturer collection program as a collection site shall provide notice to
- 93 consumers that recycling of mercury thermostats is required under Massachusetts law and the
- 94 notice shall include the specific names and locations of any collection sites within reasonably
- 95 close proximity that recycle mercury thermostats.
- 96 (c) A manufacturer that maintains a collection and recycling program may terminate a collection
- 97 location's participation in the program after two documented instances of the location shipping
- 98 mercury containing products other than thermostats. The program must first notify the location
- 99 and the Department in writing for termination to occur. Termination form a manufacturers'
- 100 program does not reduce, eliminate, or otherwise affect the collector's obligation under
- 101 subsection (c) to properly dispose of thermostats that contain mercury.
- 102 (d) Department oversight.--
- 103 (1) Each manufacturer shall submit to the department the collection and recycling program
- 104 required under subsection (a) no later than 180 days after the effective date of this section. The
- 105 proposed collection and recycling program may include appropriate enhancements to an existing
- 106 program or a new program.
- 107 (2) If the revised collection program is not submitted by the applicable date, the manufacturer
- 108 shall be considered out of compliance for the purposes of subsection (b) beginning on the date
- 109 the revised plan is due to the department.

- 110 (e) Safe management and recycling program.--The department, in cooperation with
- 111 manufacturers, shall provide education and outreach to business, local government, schools and
- the public on proper management of mercury thermostats and other products containing mercury,
- including a listing of department-approved collection sites. A list of department-approved
- 114 collection sites shall also be distributed to wholesalers, retailers and contractors or made
- available on the department's internet website.
- 116 (f) Reporting.--
- 117 (1) Each manufacturer with an approved collection and recycling program shall submit an annual
- 118 report to the department by June 1 of each year that includes:
- 119 (i) The number of mercury thermostats collected and recycled by the manufacturer pursuant to
- 120 this act during the previous year.
- 121 (ii) The estimated total amount of mercury contained in the mercury components collected by the
- manufacturer pursuant to this act during the previous year.
- 123 (iii) An evaluation of the effectiveness of the manufacturer's collection and recycling program
- and any recommendations for improvements, including modifications to the program.
- 125 (iv) Collection goals which shall be established to ensure an increase in the number of mercury
- 126 thermostats collected each year until 2015 or a time that the department determines that the
- 127 number of in-service thermostats is steadily declining as a result of the ban on sales and
- 128 installation.

- 129 (2) Within 90 days after receipt of the manufacturer's annual reports, the department shall
- 130 publish information in its Internet website about the collection and recycling of mercury
- 131 thermostats in this Commonwealth. This information shall include:
- 132 (i) A description of the collection and recycling program established under this act.
- 133 (ii) Collection goals and data on actual collection rates.
- 134 (3) In conjunction with the manufacturer, the department may alter any and all elements of the
- 135 17 manufacturer collection and recycling program, including, but not limited to, the number and
- 136 location of the collection points and collection goals and means to achieve established goals,
- provided alterations are not inconsistent with the requirements of this and other applicable laws.
- 138 (4) The Secretary of Energy and Environmental Affairs may discontinue the requirement for the
- annual report pursuant to this subsection on finding that mercury thermostats no longer pose a
- 140 threat to the environment and to public health.
