The Commonwealth of Massachusetts

In the One Hundred and Eighty-Ninth General Court (2015-2016)

An Act relative to animal abuse.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. Section 112 of Chapter 266 of the General Laws, as amended by Section 2
2	of Chapter 293 of the Acts of 2014, is further amended by striking out, "7 years in state prison or
3	imprisonment in the house of correction for not more than 2 1/2 years or by a fine of not more
4	than \$5,000 or by both fine and imprisonment; provided, however, that a second or subsequent
5	offense shall be punished by imprisonment in the state prison for not more than 10 years or by a
6	fine of not more than \$10,000 or by both such fine and imprisonment" and inserting in place
7	thereof the following words: - 10 years in a state prison or house of correction with a fine of not
8	more than \$5,000, however, that subsequent offenses shall be punished by imprisonment in the
9	state prison for not more then 15 years and a fine of not more than \$15,000.
10	SECTION 2. Section 77 of chapter 272 of the general laws, as amended by Section 3 of
11	Chapter 293 of the Acts of 2014, is further amended by striking out, "7 years in state prison or
12	imprisonment in the house of correction for not more than 2 1/2 years or by a fine of not more

13 than \$5,000 or by both fine and imprisonment; provided, however, that a second or subsequent

- 14 offense shall be punished by imprisonment in the state prison for not more than 10 years or by a
- 15 fine of not more than \$10,000 or by both such fine and imprisonment" and inserting in place
- 16 thereof the following words: 10 years in a state prison or house of correction with a fine of not
- 17 more than \$5,000 provided, however, that subsequent offenses shall be punished by
- 18 imprisonment in the state prison for not more then 15 years and a fine of not more than \$15,000.
