### The Commonwealth of Massachusetts

In the One Hundred and Ninety-Second General Court (2021-2022)

An Act relative to higher education financial literacy counseling.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Chapter 15A of the General Laws, as appearing in the 2018 Official
- 2 Edition, is hereby amended by adding at the end thereof the following new section:-
- 3 Section 45. The board of higher education shall have the authority to mandate that each
- 4 public higher education institution provide financial literacy counseling to accepted applicants of
- 5 the institution relative to student loans and other expenses to students upon arriving on campus.
- 6 The Board is further authorized to provide a College Financing Plan developed by the federal
- 7 Consumer Financial Protection Bureau and the United States Department of Education to said
- 8 accepted applicants of the institution. College Financing Plan shall include estimated cost of
- 9 attendance including tuition and fees, housing and meals, books and supplies, transportation and
- other education costs as well as grants and scholarships and work-study and loan options. The

- public institution of higher education may provide an electronic version of the College Financing
- Plan in a printable format. The board of higher education may promulgate regulations to carry
- out the purposes of this section.
