An Act to establish an office of fair housing and a fair housing trust fund.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 6A of the General Laws is hereby amended by adding the  
2 following section:-

3 Section 16DD. (a) As used in this section the following words shall, unless the context  
4 clearly requires otherwise, have the following meanings:-

5 "Office", the office of fair housing.

6 "Fair housing trust fund", the Fair Housing Trust Fund, as established by Chapter 121H.

7 (b) There shall be an office of fair housing within the executive office housing. The office  
8 shall be under the supervision and control of a director of fair housing who shall be appointed by  
9 and shall report to the secretary of housing.

10 (c) The office shall coordinate all activities of the commonwealth to eliminate housing  
11 discrimination and affirmatively further fair housing, overcome patterns of segregation, foster

12 inclusive communities free from barriers that restrict access to opportunity based on protected  
13 characteristics of Chapter 151B, and to help enforce and maintain compliance with all fair  
14 housing laws, including, but not limited to, Chapter 151B and the federal Fair Housing Act, 42  
15 U.S.C. 3601 et seq.

16 (d) The office shall collaborate with the executive offices, state agencies, and the office  
17 of the attorney general on fair housing initiatives to address the factors that influence housing  
18 discrimination, segregated communities, and disparities in access to opportunity. The executive  
19 offices shall include, but not be limited to, the executive office of health and human services, the  
20 executive office of economic development, the executive office of public safety and security, the  
21 executive office of energy and environmental affairs, the Massachusetts department of  
22 transportation, the executive office of labor and workforce development, the executive office for  
23 administration and finance, the executive office of technology services and security, and the  
24 executive office of education. The office shall facilitate communication and partnership between  
25 these executive offices and agencies to develop greater understanding of the intersections  
26 between agency activities and fair housing. The office shall facilitate the development of  
27 interagency initiatives to address the social and economic determinants of housing disparity  
28 issues including, but not limited to: (i) equal access to housing and quality; (ii) housing  
29 affordability; (iii) transportation availability, location and cost; (iv) air, water, and land usage and  
30 quality; (v) employment and workforce development; (vi) access to healthcare; (vii) education  
31 access and quality; and (viii) language access.

32 (e) The office shall administer the Fair Housing Trust Fund.

33 (f) The office shall evaluate the effectiveness of programs and interventions to eliminate  
34 housing discrimination and to affirmatively further fair housing, identifying best practices and  
35 model programs for the commonwealth.

36 (g) The office shall prepare an annual assessment of fair housing report. The report shall  
37 evaluate the progress of the commonwealth toward eliminating housing discrimination and  
38 affirmatively furthering fair housing, where possible, quantifiable measures and comparative  
39 benchmarks and, where possible, shall detail such progress on a regional basis. The report shall  
40 include a description of the activities and outcomes of the Fair Housing Trust Fund. The office  
41 shall hold public hearings in several regions of the commonwealth to gather public information  
42 on the topics of the report. The report shall be filed with the governor, the clerks of the house of  
43 representatives and senate, the chairs of the joint committee on housing not later than July 1. The  
44 report shall be posted on the official website of the commonwealth.

45 SECTION 2. The General Laws are hereby further amended by inserting after Chapter  
46 121G the following section:-

47 Chapter 121H.

48 FAIR HOUSING TRUST FUND

49 Section 1. As used in this chapter, the following words shall, unless the context clearly  
50 requires otherwise, have the following meanings:-

51 “Office”, the office of fair housing, established in section 16DD of Chapter 6A.

52 “Trust fund”, the Fair Housing Trust Fund.

53           Section 2. There shall be within the office a separate fund to be known as the Fair  
54 Housing Trust Fund. The office shall administer the trust fund for the purpose of eliminating  
55 housing discrimination and affirmatively furthering fair housing, overcoming patterns of  
56 segregation, fostering inclusive communities free from barriers that restrict access to opportunity  
57 based on protected characteristics of Chapter 151B, and to helping enforce and maintain  
58 compliance with all fair housing laws, including, but not limited to, Chapter 151B and the federal  
59 Fair Housing Act, 42 U.S.C. 3601 et seq. Activities eligible for assistance from the trust fund  
60 shall include, but not be limited to, private enforcement initiatives, education and outreach  
61 initiatives, fair housing testing, lending discrimination, affirmatively furthering fair housing, and  
62 special projects.

63           Section 3. The trust fund shall be overseen by the director of the office and an advisory  
64 board composed of at least six members representing those with protected characteristics and at  
65 least two experienced civil rights practitioners. The director and advisory board shall set the  
66 criteria for selecting grantees.

67           Section 4. Grantees eligible for assistance shall include, but not be limited to, fair housing  
68 assistance programs and fair housing initiative programs, as defined by the U.S. Department of  
69 Housing and Urban Development, any private, non-profit agency, or any state-funded public  
70 housing authority. Awards from the trust fund shall be for a period of up to three years in an  
71 amount not to exceed \$1,000,000 over three years or \$333,333 in any one year.

72           Section 5. There shall be credited to the trust fund revenue from appropriations or other  
73 monies authorized by the general court and specifically designated for the fund and any gifts,  
74 grants, private contributions, investment income earned on the fund's assets and any other

75 sources. Money remaining in the fund at the end of a fiscal year shall not revert to the General  
76 Fund.
