RESOLVE An Act establishing a crisis intervention training working group

Resolved,

- 1 SECTION 1. There is hereby established a working group to study Crisis Intervention Training
- 2 (CIT), including jail diversion, mental health courts and other matters relative to the
- 3 decriminalization of mental illness. The working group shall also study any state or local
- 4 obstacles that may hinder the broader utilization of universal and effective models throughout the
- 5 commonwealth. The working group shall report its findings and conclusions to the general court
- 6 and make recommendations regarding any necessary legislative and regulatory changes which
- 7 are suggested by those findings and conclusions. The first meeting of the working group shall
- 8 take place within 30 days after the effective date of this act.
- 9 SECTION 2. The working group shall consist of: the house and senate chairs of the joint
- 10 committee on mental health and substance abuse who shall serve as the co-chairs; two appointees
- of the national alliance on mental illness of massachusetts, one of whom shall be the executive
- 12 director; two appointees from the association of behavioral healthcare, one of whom shall be the
- 13 executive director; the commissioner of the department of mental health or his/her designee; the
- 14 secretary of public safety or his/her designee; the commissioner of the department of public

- 15 health or his/her designee; two appointees of the governor, one of whom shall be a consumer of
- 16 mental health services.
- 17 SECTION 3. In carrying out its charge, the working group shall examine, report on, and make
- 18 recommendations regarding the following matters:
- 19 a) estimates of financing and costs, as well as savings to the law enforcement communities,
- 20 of implementing effective decriminalization programs, including but not limited to the sources of
- 21 such financing, including feasible approaches to obtaining such financing;
- 22 b) examples of successful implementation of effective models implemented in the
- 23 commonwealth and other states;
- 24 c) resources, support and training needs required locally in order to offer and implement
- 25 adequate decriminalization programs, including but not limited to jail diversion, CIT, mental
- 26 health courts and other related matters;
- 27 d) the most effective and efficient methods for requiring state and local training of all public
- 28 safety personnel including exploring offering said training as part of all incoming public safety
- 29 classes;
- 30 e) the obstacles to broader utilization of decriminalization programs, including but not
- 31 limited to jail diversion, CIT, mental health courts and other programs in cities and towns;
- 32 f) best practices that presently exist within and outside of the commonwealth relative to
- 33 mental illness and the criminal justice system.
- 34 SECTION 4. The working group shall solicit advice from such persons and entities as it deems
- 35 necessary, including but not limited to the department of corrections, state agencies, associations
- 36 representing police officers and other public safety officials, consumers of mental health
- 37 services, family members of people with mental illness, and other states which have employed
- 38 effective and highly regarded programs and municipal officials.
- 39 SECTION 5. The working group shall file a report containing its recommendations, including
- 40 legislation and regulations necessary to carry out its recommendations, with the joint committee
- 41 on mental health and substance abuse and the clerks of the house and senate not later than 6
- 42 months following the first meeting of the working group.
