## The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act relative to a patient's report card of nursing

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 118G of the General laws, as appearing in the 2004 Official
- 2 Edition, is hereby amended by adding the following new section:-
- 3 Section 28:
- 4 The division shall require hospitals, nursing homes, chronic care and rehabilitation hospitals,
- 5 other specialty hospitals, clinics, including mental health clinics, all other health care institutions,
- 6 organizations and corporations licensed or registered by the department of public health and
- 7 health maintenance organizations as defined in chapter 176G to annually report appropriate data,
- 8 including, but not limited to:

- 9 measures which differentiate between severity of patient illness, readmission rates, length of
- 10 stay, patient/family satisfaction with care;
- 11 indicators of the nature and amount of nursing care directly provided by licensed nurses
- 12 including, but not limited to, the average ratio of registered nurses to patients or residents and the
- 13 average skill mix ratio of licensed and supervised unlicensed personnel to patients or residents,
- 14 medication errors, number and grades of pressure sores, number of falls, number of injuries,
- 15 number of nosocomial infections and number of preventable hospitalizations;
- 16 documentation of defined nursing interventions such as clinical assessment by a licensed
- 17 provider, pain measurement and management, skin integrity management, patient education and
- 18 discharge planning; and
- 19 documentation of patient safety measures such as restraint checks, seizure precautions and
- 20 suicidal precautions, to enable purchasers of group health insurance policies and health care
- 21 services and for the public at large to make meaningful financial and quality of care
- 22 comparisons.
- 23 The division shall consult with interested parties, including but not limited to; the group
- insurance commission, the Massachusetts nurses association, the Massachusetts health data
- 25 consortium, the Massachusetts hospital association, the public health council, Massachusetts
- 26 senior action council, associated industries of Massachusetts, a large labor union, the division of
- 27 medical assistance, the board of registration in nursing, the division of insurance, the
- 28 Massachusetts association of health maintenance organizations, and a national council of quality
- 29 assurance accreditation expert to develop methodologies for collecting and reporting data

- 30 pursuant to this section and to plan for its use and dissemination to culturally diverse
- 31 populations.
- 32 Subject to the provisions of section 2(c) of chapter 66A, information collected by the division
- pursuant to this section shall be made available annually in the form of printed reports and
- 34 through electronic medium derived from raw data and/or through computer-to-computer access.
- 35 All personal data shall be maintained with the physical safeguards enumerated in said chapter.
- 36 SECTION 2. Section 70E of Chapter 111 of the General Laws is hereby amended by
- 37 striking out in line 89 the word "and".
- 38 SECTION 3. Said section 70E of said Chapter 111, as so appearing, is hereby further
- 39 amended by striking out in line 99 the word "foregoing." and adding, the following words
- 40 "foregoing; and".
- 41 SECTION 4. Said section 70E of said Chapter 111, as so appearing, is hereby further
- 42 amended by adding at the end thereof the following new subsection:—
- 43 (o) upon request, to receive from a duly authorized representative of the facility,
- 44 disclosure of said facility's nursing care data, including but not limited to, statistics on the nature
- 45 and amount of care directly versus indirectly provided by licensed nurses in the facility,
- 46 including the average ratio of registered nurses to patients or residents and the average skill mix
- 47 ratio of licensed and supervised unlicensed personnel to patients or residents, the incidents of
- 48 nosocomial infections, skin integrity data, patient injuries, patient falls, patient satisfaction data
- 49 and the method(s) used to provide for routine care and unplanned care needs by licensed nurses,
- and further, upon request, to receive from said duly authorized representative, information
- 51 regarding the educational preparation and length of employment of said facility's nursing staff

- 52 and to receive a copy of the comparative nursing care data report as outlined in chapter 118G,
- 53 section 24 subsection (a). The fee for said report shall be determined by the rate of reasonable
- 54 copying expenses.
