An Act relative to prevailing wages.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1.

2 Section 26 of Chapter 149 of the General Laws, as appearing

3 in the 2012 Official Edition, is hereby amended by inserting in paragraph 1, line 43, after

4 words "pension plans" the following:- ", bona fide apprenticeship programs approved by the

5 commonwealth which comply with the requirements of Sections 11E to 11L, inclusive, of

6 Chapter 23 of the General Laws".

7 SECTION 2.

8 Section 27 of Chapter 149 of the General Laws, as appearing

9 in the 2012 Official Edition, is hereby amended by inserting in paragraph 1, line 42, after
10 the words "pension plans" the following: ", bona fide apprenticeship programs approved by the
11 commonwealth which comply with the requirements of sections 11E to 11L, inclusive, of
12 Chapter 23 of the General Laws".

13 SECTION 3.

14 Section 27 of Chapter 149 of the General Laws, as appearing in the 2012 Official Edition,
15 is hereby amended by inserting in paragraph 1, line 47, after the words "pension plan" the
16 following:- ", a bona fide apprenticeship

17 program approved by the commonwealth which comply with the requirements of sections
18 11E to 11L, inclusive, of Chapter 23 of the General Laws".

24 requirements of sections 11E to 11L, inclusive, of Chapter 23 of the General Laws".

25 SECTION 5.

26 Section 27 of Chapter 149 of the General Laws, as appearing in the 2012 Official Edition,
27 is hereby amended by inserting in paragraph 3, line 57, after the words "and welfare funds" the
28 following:- ", bona fide apprenticeship programs approved by the commonwealth which comply
29 with the requirements of sections 11E to 11L, inclusive, of Chapter 23 of the General Laws".

31 Section 27 of Chapter 149 of the General Laws, as appearing in the 2012 Official Edition,
32 is hereby amended by inserting paragraph 3, line 70, after the words "health and welfare funds"
33 the following:- ", bona fide apprenticeship programs approved by the commonwealth which
34 comply with the requirements of sections 11E to 11L, inclusive, of Chapter 23 of the General
35 Laws".

40 with the requirements of sections 11E to 11L, inclusive, of Chapter 23 of the General Laws".

42 Section 27 of Chapter 149 of the General Laws, as appearing in the 2012 Official Edition,
43 is hereby amended by inserting in paragraph 3, line 85, after the words "welfare funds" the
44 following:- ", bona fide apprenticeship programs approved by the commonwealth which comply
45 with the requirements of sections 1B to 11L, inclusive, of Chapter 23 of the General Laws".

46 Section 9.

47 Section 27 of Chapter 149 of the General Laws, as appearing in the 2012 Official Edition,
48 is hereby amended by inserting after the word in paragraph 3, line 49 after the word
49 "construction" the following:- " Any employer engaged in the construction of such works who
50 make payments to a health and welfare plan, a bona fide apprentice program, a pension plan and

51 a supplementary unemployment benefit plan, shall only deduct payments from wages in
52 accordance with the appropriate collective bargaining agreement.
