Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 85 of the General Laws is hereby amended by striking out section

2 15, as appearing in the 2004 Official Edition, and inserting in place thereof the following

3 section:-

4 Section 15. (a) Every vehicle, whether stationary or in motion, on any public way, shall

5 have attached to it a light or lights which shall be so displayed as to be visible from the front and

6 the rear during the period fro a half-hour after sunset to a half-hour before sunrise.

7 (b) Every vehicle, whether stationary or in motion, on any public way shall display at least 2 lighted lamps on the front and every motorcycle, whether stationary or in motion, on any 8 public way shall display at least 1 lighted lamp on the front when, due to insufficient light or 9 unfavorable atmospheric conditions, including, but not limited to, periods of snow, rain or fog, 10 persons or vehicles on the way are not clearly discernible at a distance of 500 feet ahead or it is 11 necessary to use a vehicle's windshield wipers. A violation of this paragraph shall not be 12 considered as a conviction of a moving violation of the motor vehicle laws for the purpose of 13 determining surcharges on motor vehicle premiums pursuant to section 113B of Chapter 175. 14
