An Act relative to industrial development finance authorities.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. Clause (1) of section 1 of chapter 40D of the General Laws, as so appearing
2	in the 2012 Official Edition, is hereby amended by striking out, in lines 72-73, the words "In
3	any city or in a town subject to the provisions of clause (k) of subdivision (2) of section twelve,".
4	SECTION 2. Clause (1) of section 1 of chapter 40D, as so appearing, is hereby further
5	amended by striking out the sixth sentence and inserting in place thereof the following sentence:
6	- "Bonds may be issued under this chapter to finance the costs of such facilities, including such
7	costs paid prior to the authorization of such bonds as the board of directors shall approve."
8	SECTION 3. Clause (1) of section 1 of chapter 40D, as so appearing, is hereby further

11	including low and/or moderate income housing as defined in section 20 of chapter 40B, or
12	facilities rented primarily to transient guests
13	shall be deemed an industrial enterprise within the meaning of this chapter."

15	the end of the sixth paragraph the following sentence: "For the purpose of carrying out any
16	project authorized by this chapter, a municipality acting by and through an industrial
17	development financing authority or two or more contiguous municipalities acting by and through
18	a consolidated industrial development financing authority shall have sole bond issuing authority
19	for any project undertaken within the such municipality or consolidated municipalities".
