Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

Said section 80E of chapter 112, as so appearing, is hereby further amended by adding the following sentence:- Pursuant to section 80B, a nurse practitioner may be registered to distribute, dispense, conduct research with respect to, or use in teaching or chemical analysis, a controlled substance in the course of professional practice or research in the commonwealth in accordance with regulations promulgated by the board of registration in nursing after consultation with the commissioner of public health.
