Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows: SECTION 1. Chapter 100A of the General Laws is hereby amended by striking out 2 section 1, as appearing in the 2008 Official Edition, and inserting in place thereof the following 3 section:-4 Section 1. As used in this chapter the following words shall, unless the context clearly requires 5 otherwise, have the following meanings:-

6 "Deputy director", the deputy director of standards in the office of consumer affairs and business

- 8 "Registered motor vehicle repair shop", a motor vehicle repair shop which has a current valid
- 9 certificate of registration for motor vehicle repair issued hereunder.
- 10 "Registered motor vehicle glass repair shop", a motor vehicle glass repair shop which has a
- 11 current valid certificate of registration for motor vehicle glass repair issued hereunder.
- 12 "Motor vehicle repair", the business or act of repairing damaged motor vehicles in the
- 13 commonwealth for compensation, excluding motor vehicle glass repair.
- 14 "Motor vehicle glass repair", the business or act of repairing or replacing damaged or
- 15 undamaged glass in motor vehicles in the commonwealth for compensation.
- 16 "Motor vehicle repair shop", a person or entity which, for compensation, or with the intention or
- 17 expectation of receiving the same, repairs or undertakes to repair in the commonwealth a
- 18 damaged motor vehicle as defined in section 34A of chapter 90, excluding motor vehicle glass
- 19 repair.
- 20 "Motor vehicle glass repair shop", a person or entity which, for compensation, or with the
- 21 intention or expectation of receiving the same, repairs or replaces or undertakes to repair or
- 22 replace motor vehicle glass in the commonwealth.
- 23 "Person", an individual, association, partnership or corporation, and the officers, directors and
- 24 employees of a corporation.
- 25 "Unregistered motor vehicle repair shop", a motor vehicle repair shop that does not have a
- 26 current valid certificate of registration issued hereunder, which has had its registration revoked or
- 27 suspended or which has surrendered its certificate of registration hereunder.

- 28 "Unregistered motor vehicle glass repair shop", a motor vehicle glass repair shop that does not
- 29 have a current valid certificate of registration issued hereunder, which has had its registration
- 30 revoked or suspended or which has surrendered its certificate of registration hereunder.
- 31 SECTION 2. Section 2 of said chapter 100A, as so appearing, is hereby amended by inserting
- 32 after the words "motor vehicle repair", in line 1, the following words:- or motor vehicle glass
- 33 repair.
- 34 SECTION 3. Said section 2 of said chapter 100A, as so appearing, is hereby further amended by
- 35 inserting after the words "motor vehicle repair shop", in lines 2 and 3, in each instance, the
- 36 following words:- or motor vehicle glass repair shop.
- 37 SECTION 4. Said section 2 of said chapter 100A, as so appearing, is hereby further amended by
- 38 inserting after the words "registered motor vehicle repair shop", in lines 14 and 15, 21, 23 and
- 39 24, 30 and 31 and 33, in each instance, the following words:- or registered motor vehicle glass
- 40 repair shop.
- 41 SECTION 5. Section 3 of said chapter 100A, as so appearing, is hereby amended by inserting
- 42 after the words "motor vehicle repair", in line 14, the following words:- or motor vehicle glass
- 43 repair.
- 44 SECTION 6. Said section 3 of said chapter 100A, as so appearing, is hereby further amended by
- 45 inserting after the words "registered motor vehicle repair shop", in lines 17, 19 and 20 and 22
- 46 and 23, in each instance, the following words:- or registered motor vehicle glass repair shop.

- 47 SECTION 7. Section 4 of said chapter 100A, as so appearing, is hereby amended by inserting
- 48 after the words "registered motor vehicle repair shop", in lines 6 and 7, the following words:- or
- 49 registered motor vehicle glass repair shop.
- 50 SECTION 8. Section 6 of said chapter 100A, as so appearing, is hereby amended by inserting
- 51 after the words "motor vehicle repair shops", in line 4, the following words:- and motor vehicle
- 52 glass repair shops.
- 53 SECTION 9. Section 7 of said chapter 100A, as so appearing, is hereby amended by inserting
- 54 after the words "registered motor vehicle repair shop", in line 1, the following words:- and
- 55 registered motor vehicle glass repair shop.
- 56 SECTION 10. Said section 7 of said chapter 100A, as so appearing, is hereby further amended
- 57 by inserting after the words "unregistered motor vehicle repair shop", in line 3, the following
- 58 words: or unregistered motor vehicle glass repair shop.
- 59 SECTION 11. Said section 7 of said chapter 100A, as so appearing, is hereby further amended
- 60 by inserting after the words "registered motor vehicle repair shop", in line 6, the following
- 61 words:- or a registered motor vehicle glass repair shop.
- 62 SECTION 12. Section 8 of said chapter 100A, as so appearing, is hereby amended by inserting
- 63 after the words "registered motor vehicle repair shop", in line 1, the following words:- or
- 64 registered motor vehicle glass repair shop.
- 65 SECTION 13. Said section 8 of said chapter 100A, as so appearing, is hereby further amended
- 66 by inserting after the words "motor vehicle repair", in line 2, the following words:- or motor
- 67 vehicle glass repair.

- 68 SECTION 14. Section 9 of said chapter 100A, as so appearing, is hereby amended by inserting
- 69 after the words "registered motor vehicle repair shop", in line 1, the following words:- and
- 70 registered motor vehicle glass repair shop.
- 71 SECTION 15. Said section 9 said chapter 100A, as so appearing, is hereby further amended by
- 72 adding following subsection:-
- 73 (d) A registered motor vehicle glass repair shop shall maintain records for each motor vehicle
- 74 upon which motor vehicle glass repair services have been performed, showing the usage of all
- 75 glass parts, major accessory parts including moldings and major hardware component parts and
- 76 the adhesive system used in the motor vehicle glass repair. Such adhesive system record shall
- 77 include the brand, product number or name and lot and batch numbers for the product used, and
- 78 shall be maintained for 18 months or as long as a warranty on the motor vehicle glass repair
- 79 service performed is in effect, whichever is longer.
- 80 SECTION 16. Said chapter 100A is hereby further amended by adding the following 4
- 81 sections:-
- 82 Section 11. A person applying for registration or renewal as a registered motor vehicle glass
- 83 repair shop in the commonwealth shall meet the following requirements:
- 84 (a) A registered motor vehicle glass repair shop shall maintain a physical place of business
- 85 within the commonwealth at which it has indoor facilities to perform motor vehicle glass repair
- 86 services or from which it would lawfully dispatch mobile service vans.
- 87 (b) A registered motor vehicle glass repair shop mobile service van shall be a commercial
- 88 vehicle properly registered and insured in the commonwealth.

- 89 (c) A registered motor vehicle glass repair shop shall possess and maintain in working order the equipment necessary to provide motor vehicle windshield glass stone chip repair.
- 91 (d) A registered motor vehicle glass repair shop that provides motor vehicle replacement services
- 92 shall possess and maintain the equipment necessary to perform motor vehicle glass replacement
- 93 services.
- 94 (e) A motor vehicle glass repair shop shall obtain all local, state and federal licenses and permits
- 95 including a state sales tax identification number and a federal tax identification number.
- 96 (f) A registered motor vehicle glass repair shop shall not subcontract or sublet motor vehicle
- 97 glass repair services to another person or entity not in their employ, unless such person or entity
- 98 is also a duly registered motor vehicle glass repair shop.
- 99 Section 12. (a) Upon request, a registered motor vehicle glass repair shop shall disclose to the
- 100 consumer all information relating to the charges for repair or replacement services, including the
- amount of the charges, the identification and line item charges for the parts provided and
- 02 verification of parts used, regardless of whether the amount is paid by the consumer or billed to
- 103 their insurance company.
- 104 (b) A motor vehicle glass repair shop shall advise the consumer of post-repair practices that may
- 105 be necessary to insure safe operation of the vehicle.
- 106 Section 13. The division of standards shall have the right to inspect the premises of an applicant
- or registered motor vehicle glass repair shop, for the purpose of ascertaining compliance with the
- 108 requirements of this chapter. Failure to comply with any of the requirements will result in
- 109 rejection of the application, or, if already registered, the forfeiture of motor vehicle glass shop

- 110 registration until such time as the division re-inspects the facility and determines the shop is in
- 111 compliance.
- 112 Section 14. Any motor vehicle glass repair to be performed in the commonwealth must be
- performed by a registered motor vehicle glass repair shop. A person, including an insurer,
- 114 insurance agent, third-party administrator or a motor vehicle service establishment or other party
- 115 receiving a report of or inquiry regarding motor vehicle glass damage, or a request for motor
- vehicle glass repair services shall state that such motor vehicle glass repair shall be performed by
- 117 a registered motor vehicle glass repair shop.
- 118 SECTION 17. Chapter 175 of the General Laws is hereby amended inserting after section 113W
- 119 the following section:-
- 120 Section 113X. This section shall apply to any motor vehicle glass repair which is to be
- 121 performed in the commonwealth and which is covered in whole or in part by motor vehicle
- 122 liability insurance.
- 123 (a) An insurer, insurance agent, producer, adjuster or third party administrator for such insurer
- 124 shall not:
- 125 (i) require a person to use a particular registered motor vehicle glass repair shop for such motor
- 126 vehicle glass repair;
- 127 (ii) use or employ unfair or deceptive acts or practices for the purpose of inducing a person to use
- 128 a particular registered motor vehicle glass repair shop to provide motor vehicle glass repair
- 129 services. Such unfair or deceptive acts shall include, but are not limited to, engaging in an act or

- practice designed to intimidate, threaten or coerce a person to use, or for having used, a
- 131 particular registered motor vehicle glass repair shop; or
- 132 (iii) negotiate with a motor vehicle glass repair shop to provide motor vehicle glass repair if such
- 133 repair shop is not a duly registered and licensed repair shop in the commonwealth.
- 134 (b) When an insured selects a registered motor vehicle glass repair shop to provide motor
- 135 vehicle glass repair services, an appraiser or employee of an independent appraisal company,
- insurance company, its employees or representatives or third party biller shall be prohibited from
- 137 requiring that such motor vehicle glass repair be made at a different registered motor vehicle
- 138 glass repair shop.
- 139 (c) Once a registered motor vehicle glass repair shop has been selected to provide motor vehicle
- 140 glass repair services, an insurer or third party biller shall not assign or dispatch the repair work or
- 141 forward a related policy or policyholder's contact or repair scheduling information to a different
- 142 registered motor vehicle glass repair shop without the knowledge and consent of the insured.
- 143 (d) An insured may at any point in time elect to change their choice of registered motor vehicle
- 144 glass repair shop.
- 145 (e) An insurer may, either directly or through its agents, producers, adjusters or third party
- administrator, provide directly or through other means, including electronic transmissions,
- 147 information to assist in selecting a motor vehicle glass repair shop or scheduling such motor
- 148 vehicle glass repair shop to perform motor vehicle glass repair.
- 149 (f) An insurance company, agent, producer, third party biller or adjuster for such insurance
- 150 company violating this section shall be punishable by a fine of not less than \$1,000 nor more

- 151 than \$5,000 for each violation. The fine shall be collected by the division of insurance and
- 152 deposited in a retained revenue account to be used by the division to carry out the enforcement of
- 153 this section.
- 154 SECTION 18. Section 3 of chapter 176D of the General Laws, as so appearing, is hereby
- amended by striking out subsection (12) and inserting in place thereof the following subsection:-
- 156 (12) Any violation of sections 2B, 95, 113X, 181 to 183, inclusive, 187B to 187D, inclusive,
- 157 189, 193E or 193K of chapter 175.
- 158 SECTION 19. Notwithstanding any general or special law to the contrary, a registered motor
- vehicle repair shop, as defined in section 1 of chapter 100A of the General Laws, performing
- 160 motor vehicle glass repair on the effective date of this act shall not be required to register as a
- 161 motor vehicle glass repair shop until its current registration has expired.
- 162 SECTION 20. Notwithstanding any general or special law to the contrary, a registered motor
- 163 vehicle repair shop, as defined in section 1 of chapter 100A of the General Laws, performing
- 164 motor vehicle glass repair on the effective date of this act shall not be required to register with
- 165 the division of standards as both a registered motor vehicle repair shop and a registered motor
- 166 vehicle glass repair shop.
- 167 SECTION 21. The commissioner of the division of insurance shall promulgate rules and
- 168 regulations for the administration and enforcement of section 113X of chapter 175 of the General
- 169 Laws. The regulations shall be promulgated within 180 days after the effective date of this act.
