The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act relative to school-located influenza vaccination programs.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The General Laws, as appearing in the 2008 Official Edition, shall be

- 2 amended by adding after section chapter 118H the following new chapter:
- 3 \Box Chapter 1118J:
- 4
- 5 Section 1. Definitions. The following words, as used in this section, unless a different meaning
- 6 is required by the context or is specifically prescribed, shall have the following meanings:
- 7 D"Child or Children" individuals less than nineteen years of age.
- 8 "Childhood immunizations," immunizations for children until their nineteenth birthday,
- 9 including the immunizations recommended by the federal Vaccines for Children Program.
- 10 "Participating provider", a provider who, under a contract with a health insurer or with its
- 11 contractors of subcontractors, has agreed to provide health care services to insured with an
- 12 expectation of receiving payment, other than coinsurance, co-payments or deductive, directly or
- 13 indirectly.

- 15 Section 2. The Department of Public Health in consultation with the Division of Insurance and
- 16 the Department of Education shall establish school-located influenza vaccination programs in
- 17 elementary and secondary schools to vaccinate children against influenza.
- 18 🗆
- 19 The program under this section shall be designed to administer influenza vaccines consistent
- 20 with the recommendations of the U.S. Centers for Disease Control and Prevention's Advisory
- 21 Committee on Immunization Practices (ACIP) for the annual vaccination of all eligible school-
- 22 aged children. The Department of Public Health may implement these programs through

- 23 coordination with local health departments, school nurses, school healthcare programs or other
- 24 local entities. The Department of Public Health may contract with vaccination access companies
- 25 to administer influenza vaccine in schools. In doing so, the Department of Public Health shall
- 26 work with the state Medicaid program to determine whether and how such companies may
- 27 register to receive vaccine from the Federal Vaccines for Children Program for eligible children
- 28 and reimbursement from the Medical Assistance program for administration.
- 29 Participation in the programs by a school district or an individual shall be voluntary. The
- 30 vaccine shall be administered with the consent of a student's parent or legal guardian. In
- 31 implementing the programs, the Department of Public Health shall maximize the use of influenza
- 32 vaccine available through existing public entitlement and discretionary resources and private
- 33 immunization coverage in the following manner:

- 35 □For children who are eligible for the Federal Vaccines for Children Program, the Department
- 36 of Public Health shall provide influenza vaccine for these children through existing entitlement
- 37 and discretionary funding for vaccine and work with the state Medicaid program to ensure
- 38 reimbursement for the administration fee.

- 40 \Box For children who have private insurance that covers influenza vaccination, and health
- 41 insurance plans who are licensed within the state and who provide coverage for influenza
- 42 immunization under existing policy, shall provide reimbursement for influenza vaccine and its
- 43 administration at the insurers' established rate when such vaccine is administered outside of the
- 44 physician's office in a school or pharmacy setting.

- 46 The Department of Public Health shall make information regarding federal grants and
- 47 appropriation opportunities available to local government agencies, local public health
- 48 departments, school districts, and state and local nonprofit organizations via the agency's
- 49 \Box website.
- 50 \Box The programs under this section shall not restrict the discretion of a health care provider to
- 51 administer any seasonal influenza vaccine approved by the Federal Food and Drug
- 52 Administration for use in pediatric populations. Influenza vaccine should be offered to all
- 53 Children as soon as a vaccine becomes available and before the start of the flu season and
- 54 should continue to be offered throughout the entire influenza season.

- 56 Section 2. Notwithstanding any general or special law to the contrary, health insurers, as
- 57 defined in section 34 of chapter 118T of the General Laws, shall pay to health care providers
- 58 100% of the reasonable and customary charges for routine childhood immunizations for
- 59 Massachusetts residents and immunizations for Massachusetts residents who are less than 19
- 60 years of age according to the most recent schedules recommended by the advisory Committee
- 61 on Immunization Practices of the U.S. Department of Health and Human Services, excluding
- 62 those costs covered by the Commonwealth or the federal government, and any reasonable and

- 63 customary costs associated with the administration of the vaccines. Said health insurer shall
- 64 provide such reimbursement to any health care provider who administers covered immunizations
- 65 in any facility, health care provider's office or any other setting in the Commonwealth and shall
- 66 not limit such reimbursement to providers that are participating providers.

- 68 Section 4. Not later than 90 days following the completion of the programs, the Department of
- 69 Public Health shall submit a written report on the results of the program to the House Speaker,
- 70 The Senate President, the Chairs of the Health Care Finance Committee and the House and
- 71 Senate Chairs of the Ways & Means Committees. The report shall include the following: .

- 73 \Box a) An assessment of the seasonal influenza vaccination rates of school-aged children in
- 74 localities where the program is implemented compared to the national average influenza
- 75 vaccination rates for school-aged children, including whether school-based vaccination assists in
- 76 achieving the recommendations of the Advisory Committee on Immunization Practices for
- 77 annual influenza vaccination of school-aged children; .

- 79 Db) An assessment of the utility of employing elementary schools and secondary schools as a
- 80 part of a multi-state, community-based pandemic response program that is consistent with
- 81 existing Federal and State pandemic response plans;

- 83 □c) An assessment of the feasibility of using existing state, federal and private insurance in
 84 establishing a multi-state, school-based vaccination program for seasonal influenza vaccination;
 85 □
- 86 d) An assessment of the number of education days gained by students as a result of seasonal
 87 vaccinations based on absenteeism rates;

- 89 \square e) If feasible, an assessment of other indirect benefits such as the impact on hospital visits, 90 physician visits and medication use:.

- 92 \Box f) A recommendation of whether the program under this section should be expanded.
