Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. Section 27 of chapter 94C of the General Laws, as most recently amended 1 2 by chapter 172 of the acts of 2006, is hereby further amended by striking out, in lines 1, 5 and 6, 3 where they appear, the words "hypodermic syringes or hypodermic needles" and inserting in 4 place thereof in each instance, the following words:- retracting hypodermic syringes or 5 retracting hypodermic needles. 6 SECTION 2.
