In the Year Two Thousand Eleven

An Act increasing the liability for permitting an intoxicated arrestee to operate a motor vehicle..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 90 of the General Laws, as appearing in the 2008 Official Edition, is
- 2 hereby amended by inserting after section 24X, the following new section:—
- 3 Section 24Y. (a) Any vehicle operated by a person arrested for a violation of subparagraph (1)
- 4 of paragraph (a) of section 24 or section 24L shall be removed and impounded as provided by
- 5 the provisions of this section, section 69L of chapter 111 and section 2C of chapter 85 and any
- 6 rule or regulation adopted thereunder, for a period not less than 12 hours from the time of such
- 7 arrest.

8 (b) Whenever a person is summoned by or on behalf of a person who has been arrested for a
9 violation of subparagraph (1) of paragraph (a) of section 24 or section 24L, in order to transport
10 or accompany the arrestee from the premises of a law enforcement agency, the law enforcement
11 agency shall provide that person with a written statement advising that person of the potential
12 criminal and civil liability for permitting or facilitating the arrestee's operation of a motor
13 vehicle while the arrestee remains under the influence or impaired by alcohol, drugs, drugs and
14 alcohol, a controlled dangerous substance, or any combination thereof.

15 (1) The person to whom the statement is issued shall acknowledge, in writing, receipt of the
16 statement, or the law enforcement agency shall record the fact that the written statement was
17 provided, but the person refused to sign an acknowledgment.

18 (2) The attorney general shall establish the content and form of the written statement and
19 acknowledgment to be used by law enforcement agencies throughout the commonwealth.

20 (3) Nothing in this section shall impose any obligation on a physician or other health care
21 provider involved in the treatment or evaluation of the arrestee.

22 (c) A motor vehicle impounded under this section may not be released unless the person
23 claiming the motor vehicle:

24 Presents a valid driver's license, proof of ownership of or lawful authority to operate the motor
25 vehicle, and proof of valid motor vehicle insurance for that motor vehicle, or

26 Subject to review of the district court, meets any other reasonable condition for release that is
27 established by the law enforcement agency.

28 (d) A law enforcement agency that impounds a motor vehicle under this section may charge a
29 reasonable fee for towing and storage of the motor vehicle and may retain the motor vehicle until
30 the fee is paid.
