An Act relative to fetal homicide.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Chapter 265 of the General Laws, as appearing in the 2008 Official Edition, is
- 2 hereby amended by adding the following section:--
- 3 Section 13M. (a) For the purposes of this section, the following words shall, unless the context
- 4 indicates otherwise, have the following meanings:—
- 5 "Bodily injury", substantial impairment of the physical condition including any burn, fracture of
- 6 any bone, subdural hematoma, injury to any internal organ, any injury which occurs as the result
- 7 of repeated harm to any bodily function or organ including human skin or any physical condition
- 8 which substantially imperils a child's health or welfare.

- 9 "Child in utero", a member of the species homo sapiens, at any stage of development, who is
- 10 carried in the womb.
- 11 (b) Whoever engages in conduct that violates any of the provisions of law listed in chapter 265
- 12 of the General Laws which results in the death of, or bodily injury to, a child in utero when the
- 13 conduct occurs, is guilty of a separate offense under this section.
- 14 (c) (1) Except as otherwise provided in this subsection, the punishment for that separate offense
- 15 is the same as the punishment provided under the General Laws for that conduct had the injury
- 16 or death occurred to the unborn child's mother.
- 17 (2) An offense under this section does not require proof that-
- 18 the person engaging in the conduct had knowledge or should have had knowledge that the victim
- 19 of the underlying offense was pregnant; or
- 20 the defendant intended to cause the death of, or bodily injury to, the unborn child
- 21 (d) Nothing in this section shall be construed to permit the prosecution-
- 22 of any person for conduct relating to an abortion for which the consent of the pregnant woman,
- 23 or a person authorized by law to act on her behalf, has been obtained or for which such consent is
- 24 required by law;
- 25 of any person for any medical treatment of the pregnant woman or her unborn child; or
- of any woman with respect to her unborn child.
