By Mr. Day of Stoneham (by request), a petition (accompanied by bill, House, No. 2257) of Vincent Lawrence Dixon for legislation to authorizes the Executive Office of Health and Human Service and the Department of Public Health to create a nursing scholarship program. Public Health.

**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act to encourage, and improve, the level of availability of nursing staff.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The Massachusetts General Laws are hereby amended by inserting the  
2 following new chapter:

3 PURPOSE – A variety of circumstances, having developed in recent years, have led to  
4 the erosion of staffing levels, among nursing, and health care workers. These circumstances have  
5 included the migration of some such workers, into other fields; the retirement of many, and other  
6 factors including work loads, and compensation levels.

7 Recent events, particularly the COVID-19 Pandemic, and other factors, have led to the  
8 death of many nurses, and other health care workers, further adding to the significant shortage of  
9 such staff.

10 In addition, profound changes in medical treatment modalities, significant lengthening of  
11 life spans, of many; and newer recognized diseases, and conditions, have meant that there are  
12 some increases in the need for nurses, and related health care workers.

13 Significantly, Massachusetts has become a world leader in medicine, and health care, and  
14 attracts substantial numbers of patients, from across The United States and the World.

15 Thus, it has become clear that a shortage of nurses, and related health care workers, is  
16 worsening, and is likely to worsen further; adding to crisis type risks, and actual crisis  
17 circumstances, in the health care system of our Commonwealth; over a span of some years,  
18 going forward. This statute has as its purpose, to address, and help to remedy, these shortages;  
19 and provide additional mechanisms, by which individuals, and institutions, can recruit, train,  
20 employ, and otherwise stabilize, and seek to improve the nursing, and health care work force.

21 SECTION 2 – This legislation authorizes the Executive Office of Health and Human  
22 Services, and under it, the Department of Public Health, to create a Nursing Scholarship  
23 Program.

24 2a.) This Nursing Scholarship Program (NSP), shall provide a mechanism for all  
25 qualified students, who wish to enroll in an accredited Nursing Program, operated within The  
26 Commonwealth of Massachusetts, to receive specific assistance in obtaining grant, and/or  
27 scholarship aid, to compensate their educational, and related costs, as long as they meet certain  
28 specified standards.

29 2b.) Those students receiving assistance through the Nursing Scholarship Program (NSP),  
30 shall attend at least half-time, and preferably full-time, during their academic, and clinical  
31 training.

32           2c.) Such eligible students, shall, upon graduation, commit to no less than two (2) years  
33 of full-time service, in a qualified medical institution, and/or health care facility, within the  
34 boundaries of Massachusetts, as may be further defined.

35           SECTION 3 – All such eligible Nursing Scholarship Program (NSP) students, shall  
36 receive up to four (4) years of complete tuition compensation, during their studies in an  
37 accredited Bachelor of Science, Nursing Degree Program.

38           3a.) The Department of Public Health, is authorized to develop such program, and may,  
39 as needed, intersect with other agencies of the Commonwealth, to develop additional related  
40 standards.

41           3b.) Detailed records, for students in the program, shall be kept, processed, analyzed, and  
42 further reported, together with useful recommendations, for the refinement of the program. This  
43 public report, shall be done on a yearly basis.
