An Act relative to recreational vehicles.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 90B Section 1 through section 38 of the General Laws, as appearing in the  
2 2000 Official Edition, is hereby amended by striking, wherever they appear, the following  
3 words:- “the division of law enforcement of the department of fisheries, wildlife and  
4 environmental law enforcement” and inserting in place thereof the words “office of law  
5 enforcement of the executive office of environmental affairs”.

6 SECTION 2. Chapter 90B, is hereby amended by adding after Section 26 the following new  
7 section:- “Section 26A. No person shall operate a recreational vehicle on any public or private  
8 land in a manner so as to cause damage to flora or fauna, unless: (a) the operator is the owner or  
9 lessee or immediate family member of said owner or lessee of such property; or (b) the operator

10 has in his possession a written document, signed by the owner or lessee of such property,  
11 authorizing the operation of a recreational vehicle on such property; or (c) the owner or lessee of  
12 such property has designated the area for use by such recreational vehicles by posting reasonable  
13 notice of such designation in a manner approved by the director”.

14 SECTION 3. Chapter 90B Section 34 is hereby amended by striking the following words:-  
15 “twenty-six to twenty-eight, inclusive” and inserting in place thereof the words “twenty-six,  
16 twenty-seven and twenty-eight”.

17 SECTION 4. Chapter 90B Section 34 is further amended by adding at the end thereof, the  
18 following new paragraph:- “Whoever violates Section 26A, shall be punished by a fine of not  
19 less than one hundred fifty dollars nor more than five hundred dollars for the first offense or by a  
20 fine of not less than two hundred and fifty dollars nor more than one thousand dollars and  
21 forfeiture of the recreational vehicle for a second or subsequent offense.”.
