The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act relative to the retirement of certain employees of the Massachusetts Water Resources Authority.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Notwithstanding section 4 of chapter 32 of the General Laws or any other
- 2 general or special laws to the contrary, any employee of the Massachusetts Water Resources
- 3 Authority, whose employment was terminated in 2003 due to a reduction in force and
- 4 subsequently was reinstated on or before January 01, 2005 shall be credited with active service
- 5 for such period of unemployment for the purposes of said chapter 32 if the employees pay into
- 6 the Retirement System Annuity Savings Fund, in 1 sum or in installments, as said board shall
- 7 determine, an amount equal to any retirement allowance or accumulated regular deductions
- 8 received by the employees under said chapter 32.
- 9 The employees shall also pay into the annuity savings fund, in 1 sum or installments, as
- 0 the board shall determine, an equal amount or amounts which would have been deducted from
- 11 the regular compensation of the employees for the period of time of their forced unemployment
- 12 had the employees been members in service during that period. In addition to the payment of the
- 13 amount required by the preceding sentence, the employees shall also pay into said annuity
- 14 savings fund an amount of interest such that upon the completion of such payments the value of

- 15 their accumulated payments under this paragraph together with regular interest thereon, shall
- 16 equal the value of their accumulated regular deductions for such period which would have
- 17 resulted if such deductions had actually been made regular compensation during the
- 18 aforementioned period.
- 19 Upon the completion of the payments required hereunder, the retirement board of the
- 20 Massachusetts Water Resources Authority shall grant to the employees creditable service for the
- 21 period of their forced unemployment, but no such credit shall be granted until such payments are
- 22 completed.
- SECTION 2. This act shall take effort upon its passage.
