Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 1 of Chapter 64H, as appearing in the 2012 Official Edition, is
- hereby amended by inserting, after the definition of "Retail establishment", the following new
- definition:-
- "Rolling stock", vehicles such as trucks, tractors, trailers, and railcars that transport 4
- people or goods in interstate commerce.
- 6 SECTION 2. Section 6 of Chapter 64H, as most recently amended by chapter 165 of the
- acts of 2014, is hereby further amended by inserting, after subsection (xx), the following new
- subsection:
- 9 "(yy) sales of rolling stock"

- SECTION 3. Section 1 of Chapter 64I, as appearing in the 2012 Official Edition, is
- 11 amended by inserting in line 6, after the words "retail sale", the following new words:- "rolling
- 12 stock", .
- SECTION 4. Section 7 of chapter 64I of the general laws, as so appearing, is hereby
- 14 amended by inserting, after subsection (e), the following new subsection:-
- "(f) storage, use or other consumption of rolling stock".
